AGENDA ITEM NO. 6 – GUESTS – GEORGINA VILLENEUVE & JEFF FRKETICH OF PEACE HILLS TRUST – TORONTO PURCHASE TRUST - PRESENTATION OF THE FINANCIAL STATEMENTS FOR 2016, PERFORMANCE REPORT & INTERIM REPORT

Before discussing the Trust, Georgina questioned who of Council would be attending the seminar in Rama on April 27th. It was agreed that all of Chief and Council would register, but only those who are able to attend will go. Councillor Margaret Sault has offered to do the opening prayer.

Georgina pointed out that the Opinion Page of the Financial Statements is very important which states:

"In our opinion, the Financial Statements present fairly, in all material respects, the financial position of the Mississaugas of the New Credit First Nation Toronto Purchase Trust as at December 31, 2016 and the results of its operations, changes in accumulated surplus and net financial assets, re-measurement gains and its changes in financial position for the year then ended in accordance with Canadian public sector accounting standards".

Georgina stated that it is a clean Audit. This Audit will be presented at the Monthly Gatherings for March and April 2017. The Alternative Investments are up by \$1.4 Million.

Jeff informed that Empire Global is now public as well as Zoompass (formerly Paymobile). WeedMD is not public yet, but hopefully will be in about three to four months. In 12 to 18 months New Credit should be getting some dollars back on this investment.

Regarding the Mercer's Report (part of the Performance Report), this is the financial responsibility of Peace Hills Trust. The goal of the Mercer Report is to try to be above the benchmark over the long term.

Jeff noted that Buetel Goodman and Dixon Mitchell met the benchmarks, Mawer did not. Chief stated that MNCFN has invested \$13 Million in Mawer, and maybe this was a mistake. Jeff answered that no one knows what President Trump wants to do, but the markets like what he is saying. Jeff also noted that interest rates will not go up in 2017. Trump is wanting to bring jobs back from Mexico, and importing will hurt the investments.

Georgina questioned if the Managers will be needed at the Monthly Gatherings, but it was agreed that Georgina and Jeff would just do a summary. And further, she would like the Audit handed out to everyone.

Further, it appears this firm did not have experience with First Nations.

Proposals were received from MNP LLP, KPMG LLP, and Grant Thornton LLP.

Councillor stated that she was not happy with the performance of KPMG during an earlier audit.

Executive Director stated that New Credit has to notify INAC and a pre-audit meeting has to be scheduled.
