### **Mississaugas of the Credit First Nation Constitution**

The Governance team has begun its work on drafting a constitution for MCFN that will be submitted to **MCFN** Council and members for review, guidance, and approval. The constitution will be a fundamental law of MCFN. It will address MCFN's sense of itself, how

it is governed, how the membership has input into governance, key positions of its government, and its powers. At this time, the Governance team believes that a high-level constitution will be a good starting point for MCFN. This ensures that MCFN can begin to

establish its laws and powers, as well as begin to tie in some of the work that the Governance team is undertaking presently around governance. The constitution will be redrafted in future years to include more detail.

#### Mississaugas of the Credit First Nation Election Code

The Lands, Research, and Membership Department, in coordination with the Governance team, is currently drafting a MCFN election code to be used in consultations with MCFN members.

If approved by members, MCFN's election code will be used for future MCFN elections, rather than MCFN running its elections under the Indian Act. The election code will be drafted specifically for use

by MCFN. It is the hope of MCFN Council that the election code can be used for the upcoming 2019 MCFN Chief and Council election.

#### **Mississaugas of the Credit First Nation Water Framework**

The Mississaugas of the Credit First Nation (MCFN) have unextinguished Aboriginal title to all water and floodplains within our Treaty Lands and Territory, which contains approximately 4 million acres of land. The water within our Treaty Lands and Territory has never been lawfully surrendered by the MCFN or its ancestors. The treaties that our ancestors signed with the British Crown (with the exception being Treaty No. 23) did not speak to the water.

Based on this, and further evidence provided in a number of research reports on MCFN's water, we filed an Aboriginal Title Claim to Waters within the Traditional Lands of the Mississaugas of the New Credit (Water Claim) in September 2016. In support of this Water Claim, we have partnered with University of Guelph

doctoral student, Renee LeRoux-Goretsky, to develop a MCFNled Water Framework designed to transform the current water governance to meet our needs. This framework is built on community

participatory research involving 200 MCFN community members through interviews, focus group discussions, interactive art activities, and a survey.

The Water Framework provides principles for transformative and strategic engagements as part of the Water Claim and other broader applications. The 3 guiding principles chosen by the people for the Water Framework are: Becoming Self-Sustaining, Protecting the Water, and Reconnecting with our Cultural & Spiritual relations to Water. The intention is to expand on these principles so as to develop programs of community action, mobilization and development. The long-term goal of the framework is to help lead the way to reconciliation and our own self-determination by being the stewards of the water within our **Treaty Lands and Territory.** 

This Agreement is currently being drafted by MCFN and Canada. Once finalized and signed, it will establish measures to preserve the ability of MCFN and Canada to continue to have meaningful dis-
