Inspector Carter went through his Monthly Reports.

It was rumoured that someone passed away in the Townline Estates. Inspector Carter stated he was not aware of it.

Councillor LS stated that there are too many deaths from drugs and questioned what can be done.

The Housing Director is working with Brian Finnigan (Legal Counsel) and will be bringing a document back to Chief and Council for approval regarding evicting people from our properties if there is a drug overdose or death. There are drug users and drug dealers living on our properties. Councillor LS informed that we have choices regarding our rental properties, and Councillor SL (Pillar 6 Lead) needs to work with the Housing Director. Chief Operating Officer will work with the SHS Director.

Councillor CJ believes that a notice should be sent to the Community from leadership. Councillor LS added that leadership leads, and cannot just talk.

Councillor VKJ informed that this item is on the Agenda for the Mississauga Nation Meeting eg opiate crisis in the Peterborough area.

Inspector Carter informed that the Community Street Crime Unit has been doing some good work. One of the OPP's main concerns is opiates laced with fentanyl.

Councillor EF questioned when our Liaison person would get any reports. Inspector Carter stated that the OPP protocol has changed. He will speak with Kelly Daniels in his detachment. Councillor EF stated that if no names are released by the OPP, we do not know and cannot help.

Councillor VKJ questioned Councillor SL if she was doing anything about this situation, and Councillor SL replied yes. Councillor EF suggested that something be put on the Agenda for Monday, September 23, 2019 regarding drugs in our Community.

Councillor LS questioned if the child who was mauled happened on any of our properties, and was the dog put down? Inspector Carter will follow up regarding the dog and the condition of the child.

Going forward, Councillor SL will forward a list of our band owned properties to Inspector Phil Carter.

Councillor LS questioned why we are not hiring a By-Law Officer. Chief Operating Officer will put this item on an Agenda in the near future.
