November: 17 Incidents (2015 – 24 incidents, 2014 - 30 incidents).

Breakdown of Incidents:

911 Cellular pocket dial, Police located person to confirm no emergency. **Alarm** at residence, Police attended panic alarm deemed to be false, related to theft in

progress.

2 Domestic disputes: All non-criminal, verbal disagreements.

Hunting complaint: Report of gunshots. Caller advised people have permission to hunt but feels they are too close to the house. Area patrol by officer, no further gun shots were heard. **Fraud**: Internet scam, victim transferred funds in total of \$15,000.

Medical assistance: Assist ambulance personnel with suicidal youth.

3 Motor Vehicle Collisions: Car into ditch, Car vs Deer, recovered stolen vehicle.

AGENDA ITEM NO. 6 – COMMUNICATION PLAN FOR CKRZ & JUKASA RADIO (COMMUNICATIONS DIRECTOR)

Communications Director noted that on December 12th, 2016, MNCFN Education and Social Services Council directed her to present an overall communications strategy regarding CKRZ and Jukasa Radio at Regular Council on January 23rd.

Communications Director has had several meetings with Jukasa, but one meeting with CKRZ on January 17, 2017 giving little time for negotiations.

In 2012, Council donated \$20,000.00 to CKRZ Radio and did not make use of the time.

Communications Director is suggesting once per month – monthly 30 minute pre-recorded interviews and updates from Chief R. Stacey Laforme. If using Jukasa the total cost will be \$13,068.00; CKRZ's total cost would be approximately \$3,280.00. Councillor noted a huge difference in price.

Councillor suggested using CKRZ for one year.

It was agreed that this item would be put on hold for the time being until the new budgets have been approved.
