The SONICS Inc's board are seeking to appoint of one new member to ensure we have the capacity and skills to oversee the next phase of our work; financial, policy and/or lobbying backgrounds are always welcomed additions to the Board. The roles are unpaid voluntary positions. Reasonable expenses are paid. Board members are expected to attend six board meetings per year, but also to participate in the life of the organization between board meetings and acting in an ambassadorial role for The SONICS Inc. Board meetings are currently held the second Tuesday of the Month. Positions are held for a period of 3 years (term may be renewed).

About SONICS Inc CKRZ

In January 2018 we will be celebrating 28 years of around the clock programming. In the past year, CKRZ has received a \$210,000 grant from Economic Development Trust to upgrade the technology and move from an analog to digital. We received a CRTC approved increase to expand our reach from 250 watts to 5000 reaching to Ingersoll, Tillsonburg, Oakville, Kitchener, Fonthill, and Hamilton areas. Six Nations Elected Council provided a \$25,000 grant to CRKZ towards the replacement installation of our outdated and problematic bell data line with fiber. In July 2017 we completed the updating of our Ojibway, Cayuga, Onondaga, and Mohawk Languages through a \$30,000 grant received by Heritage Canada. CKRZ is awaiting a response to our most recent request to Economic Development Trust replace outdated exterior equipment such as the transmitter, generator and construction of the building to house and protect our investment. We are also in the planning stages of hosting the first CKRZ Music Festival in May 2018.
