# AGENDA ITEM NO. 5 - MINISTRY OF EDUCATION TRANSFER PAYMENT AGREEMENT FOR FISCAL 2020-2021 (DIRECTOR OF CHILD CARE & EARLYON PROGRAMS)

Director of Child Care & EarlyON Programs (Patti Barber) noted in her Briefing Note that her department has received the Ontario Transfer Payment Funding Agreement from the Ministry of Education (MEDU) for the fiscal year 2020-2021 in the amount of \$1,009,805.00.

The signed agreement is due by October 27, 2020.

We are currently operating and have submitted our budgets reflecting the following:

- Child Care MEDU funding in the amount of \$722,561.00
- MCFN EarlyON Child and Family Program in the amount of \$187,550.00

These additional funds will be added to the Child Care and EarlyON budgets:

- Child Care one-time adjustment for repairs and maintenance in the amount of \$9,020.00 for the carry over of the driveway project of additional parking spaces and the duct cleaning cost.
- Safe Restart funding for Child Care in the amount of \$71,988.00 and for EarlyON Child and Family Program \$18,685.00.
- for a grand total of \$1,009,805.00.
