Housing Director zoomed in at 10:10 am.

AGENDA ITEM NO. 5 – HOUSING REVISIONS – ONE APPLICATION FOR ALL PROGRAMS AND APPENDICES – HOUSING NEW, HRRS & SUBDIVISION HOUSING PURCHASE; 2021/22-2022-24 MCFN TOWNLINE ESTATES LEASE AGREEMENT & MCFN ELDERS LEASE AGREEMENT (HOUSING DIRECTOR)

Housing Director informed that she worked with Brian Finnigan (Legal Counsel) on the Housing Revisions, but not much has changed with the exception of the word "Band" has been removed, and the titles of staff have changed a bit.

Chief questioned the Housing Director on how she determines the selection on who gets a house. Housing Director answered that she goes through the Housing List, and starts with 1 to 25. If no one is ready to build, then she goes on to 26 and on. She stated that this procedure is not in the Housing Agreement, but it is a process that always has been done this way, and that allows the Members to see where they are on the list. She believes that it would be easier to go through the whole list instead of going from 1 to 25 and so on.

Chief stated that everything should be in an itemized list, and Members must meet these criteria. He would like further understanding of the process so he can convey this information to Members. Housing Director questioned if she could add an itemized list to each letter that she sends out.

Chief requested that a Housing Committee be formed in the very near future that would include some Members as well as the Housing Director and members from Council. This can be decided after we have a formal meeting with the team. Housing Director informed that there was a Housing Committee already formed, and we can build on this.

Housing Director stated that the Elders Agreement needs approval.

Regarding pets, Housing Director advised that this needs to be discussed with Chief and Council, but we can do that further down the road.

Executive Director of Operations questioned if Chief and Council are open to having pets in the apartments.
