## AGENDA ITEM NO. 9 – MNCFN COMMUNITY TRUST – INDIGENOUS READS BOOK CLUB FUNDING (DIRECTOR OF LIFELONG LEARNING)

Early Years Administrator noted in her Briefing Note that she is seeking to apply to the MNCFN Community Trust for the amount of \$20,000.00 (Twenty Thousand Dollars and zero cents) for the April 1, 2023 to March 31, 2024 fiscal year to continue to fund the Indigenous Reads Book Club. This Indigenous Reads Book Club will be open to all MCFN Members and facilitated through the Indigenous Led EarlyON.

## AGENDA ITEM NO. 10 – PLAYGROUND UPDATES FOR MAAWDOO MAAJAAMIN CHILD CARE (EARLY YEARS ADMINISTRATOR)

Early Years Administrator noted in her Briefing Note that she is seeking Chief and Council to approve the expenditure of \$65,377.13 (Sixty Five Thousand, three hundred and seventy seven dollars and thirteen cents) to make improvements to the existing playgrounds at Maawdoo Maajaamin Child Care (MMCC). These funds will come out of the Indigenous Led Child Care and EarlyON program funding. We also ask that the Agreement be approved and signed.

The playground at MMCC requires a sidewalk outside of the fenced area in order to provide ease of access to and from the building for children, parents and staff who park on the South end of the parking lot. This sidewalk will also provide a secondary exit for children and staff for monthly fire drills. A windbreak is required for the playground area as the site is frequently exposed to high winds that whip sand and debris causing outdoor play to be unpleasant. In order to improve and enhance the playground, a cedar windbreak is proposed for both practicality and cultural relevance. Finally, the sod areas inside the fenced zones after 4 seasons of use have become bare. Turf is requested in order to provide a grass play area. Therefore, we are seeking permission for Maawdoo Maajaamin Child Care to enter into a contract with our preferred vendor, Earthscape Play Inc. in the amount of \$65,377.13 (Sixty Five Thousand, three hundred and seventy seven dollars and thirteen cents). There is a 10% (ten percent) deposit required once the contract has been signed in the amount of \$6,537.71 (Six thousand, five hundred and thirty seven dollars and seventy one cents).

# **MOTION NO. 6**

## AGENDA ITEM NO. 11 – INDIGENOUS EARLY LEARNING AND CHILD CARE (IELCC) FUNDING (DIRECTOR OF LIFELONG LEARNING)

Director of Lifelong Learning indicated in her Briefing Note that she is seeking approval to apply for Indigenous Early Learning and Child Care funding. The Government of Canada has opened applications for funding under the Indigenous Early Learning and Child Care (IELCC) with a deadline of April 11, 2023.

As a result of the Department of Lifelong Learning Strategic Planning Session held in February, a proposed pilot project was drafted (Indigenous Early Learning Framework Pilot Project for 2023/2024 and 2024/2025) and a presentation and feedback meeting was held with Lloyd S. King Elementary Staff - Kindergarten Team, Special Education Resource Teachers and Curriculum Lead. The Department of Lifelong Learning is seeking approval to apply for funding under the IELCC funding stream for a two year Early Years Framework pilot program. We are also seeking the approval to retain the services of Jennifer Kirkham of the Mysterious Cat Productions to assist with the proposal/application writing to the Government of Canada, IELCC. We understand that Ms. Kirkham will have availability mid-March. There are early year's governance dollars available for the eligible expense to cover the cost of Ms. Kirkham's services.
