### AGENDA ITEM NO. 5a) - FURTHER DISCUSSION ON MCFN CONSTITUTION

Director of Governance (Margaret Sault) would like Gimaa and Council to approve/acknowledge the results of the April 22, 2023 Constitution Ratification.

Below is some background information:

- In September 2018, Council agreed to work on the development of the MCFN Constitution;
- August 7, 2020 the Constitution Sub-Committee was mandated to carry out this task under Pillar 7 Lead (Councillor Julie Laforme);
- Postings went out for interested MCFN Members to sit on this Committee;
- September 7, 2020, Council approved the Constitution Committee which was made up of three Youths, one Knowledge Keeper, Pillar 7 Lead and LMR Director;
- The Sub-Committee Members were Youths Austin Sault, Tomasita LaForme and Clarice King, Knowledge Keeper Harry LaForme, LMR Director and Pillar 7 Lead Julie Laforme;
- The first meeting of the Sub-Committee was held in September 2021; unfortunately, one Youth had to resign as their school workload was too heavy;
- July 2022, a finished draft went to Council where comments and changes were made;

- A number of engagement sessions were held via zoom and in-person;
- January 2023, Council appointed the Ratification Officer and set April 22, 2023 as the day of the vote for the Constitution Ratification;
- Since MCFN does not have the Approval Law approved, the Indian Referendum, Election Procedures and Indian Act were used as guidelines;
- The Indian Referendum Regulations does not address the method of determining the results, the Elections and Indian Act says a majority of votes of the electors;
- The vote has taken place and below are the results:

Councillor CS stated that there was a lot of negative feedback. The vote should have been 50% + 1. She added that it was a very low count for such a major decision. There is a lot of strife on the Facebook Page. Executive Director of Operations answered that it is not all negative on Facebook.

Executive Director of Intergovernmental Affairs stated that it was 50% + 1 of the voter turnout. She reached out to Alex Monem (Legal Counsel) who said it is a minor occurrence.

Governance Director (Margaret Sault) informed that we have always went beyond the norm to inform the MCFN Membership, and we have done our due diligence.

Councillor FS questioned why we are not hearing from anyone who participated. Her biggest concern is the small number who voted and made this major decision.

Executive Director of Intergovernmental Affairs stated that she gets very offended when people say we do nothing. She added that the next step is the Approval Law.

Councillor EF noted that people say it is not easy to find things on the MCFN Website. She further stated that she would like to hear the Chief say something. She also reiterated that this term of Council was acclimated, not voted in.

Councillor AS informed that MCFN Members who live on-reserve were not sent the voting package, and off-reserve were. She stated that she has no issue with the Constitution.

Councillor AK questioned if we are practicing the seven Grandfather Teachings. She also stated that we should not overturn this decision.

Executive Director of Intergovernmental Affairs pointed out that she will collect all the comments and make up a list.

Gimaa Stacey informed that we should have addressed the acclamation. He also believes that this First Nation is very divided on politics, however, it would be political suicide to overturn this decision.

Councillor EF noted that Gimaa and Council have put by-laws in place that we cannot enforce.

Executive Director of Operations stated that this is a valid vote, and it has been validly ratified.

Councillor KL stated that he would be upset if this vote is overturned.

Governance Director stated that we have to educate people even more. We sent out 1,045 mail out packages. The Constitution is only the first step. We can learn from this and go on.

Councillor CS believes that it will be political suicide if we do not overturn this vote.

Nothing will be posted until next week after there has been further discussion and approval.

Opposed: Councillor Claire Sault – There were too few MCFN Members making a major decision for the First Nation; Councillor Erma Ferrell – The vote should have been postponed as there are very serious concerns that need further discussion.
