

# **RBG Eaglet Naming Contest**

# ROYAL BOTANICAL GARDENS June 1 to 15, 2023

The following are the rules ("Rules") for Royal Botanical Gardens (RBG) Eaglet Naming Contest (the "Contest") being administered by Royal Botanical Gardens.

## 1. ELIGIBILITY

To be eligible for the Giveaway, entrants must be legal residents of Canada (excluding the province of Quebec) and be the age of majority or older at the time of entry in their province or territory of residence. Employees of Royal Botanical Gardens and its affiliates, subsidiaries, related companies, advertising and promotional agencies and the household members of any of the above, are not eligible to participate in the Giveaway.

## 2. HOW TO ENTER

NO PURCHASE NECESSARY. Eligible participants who suggest a name for each of the two Cootes Paradise eaglets to be named in 2023 can enter by the following method:

- Comment up to two name submissions on the pinned contest post on RBG's social media (Instagram, Facebook, or Twitter)
- Submit name(s) through the submission form at rbg.ca/bald-eagles

Up to two (2) names may be submitted with each entry. Each entry shall be considered a single entry. Entries must be received by RBG by 23:59 EST, Sunday, June 11 2023 to be eligible for the Prize.

### 3. CONTEST PERIOD

The submission period shall run from Thursday, June 1, at 10 a.m. to Sunday, June 11, at 23:59 EST after which time no further entries will be considered.

Following the submission period, a shortlist of the top 5 names will be selected by the RBG selection committee. The shortlist will open to the community to vote on the names for the two RBG eaglets online at rbg.ca/bald-ealges. The voting period will run from Monday, June 12 at 3 p.m. to Thursday, June 15 at 11:59 p.m.

#### 3. SELECTION OF WINNERS

Within the Contest period, there will be two (2) eaglet names selected for the Contest as voted on by the community at rbg.ca/bald-eagles.

The winners will be contacted by email and will have 72 hours to respond and provide their contact information including full name, email address, resident address (for the Prize only) and phone number.

Should the winners not respond within the 72 hours as per the official Contest Rules & Regulations. There will be no further backup draws conducted.

### 4. PRIZE[S]

There are two Prizes available to be won, each of which consists of a one-year single membership at Royal Botanical Gardens. The approximate value of the prize is \$85.00 (VALUE IN CDN).

The Prize(s) is not transferable and not redeemable for cash, nor will it be extended under any circumstances and must be accepted as offered without substitution.

#### 5. GENERAL

By participating in the Contest, you agree to abide by these Rules & Regulations and the decisions of RBG which shall be final and binding in all respects. Entrants who have not complied with these Rules & Regulations are subject to disqualification.

Notwithstanding the defined Contest Period, RBG reserves the right, in its sole discretion, to terminate the Contest, in whole or part, and/or modify, amend or suspend the Contest, and/or these Rules in any way, at any time, for any reason without prior notice.

By participating in the Contest, the Prize Winner(s) agree(s) that the eaglet name may be used in any and all forms of media, without any further compensation by RBG and waives all rights (including moral rights) with respect to printed, broadcast and other forms of publicity.

The Contest is subject to all applicable laws of the province of Ontario and the laws of Canada applicable therein.

The Contest is not endorsed, administered, or sponsored by Instagram, Facebook, or Twitter.

### 6. RULES

1. These rules govern the Royal Botanical Gardens (RBG) Eaglet Naming Contest ("Contest").

- 2. The Contest is open to residents of Canada (excluding the province of Quebec) and are the age of majority or older at the time of entry in their province or territory of residence. RBG Corporate affiliates, advertising or promotional agencies, employees, immediate family of employees, or anyone residing with any employee of RBG is not eligible to participate.
- 3. The act of entering the Contest constitutes acceptance of the contest Rules & Regulations and the decisions of the Contest judge, which decisions shall be final and binding upon all entrants.
- 4. By participating in the Contest, each Entrant grants RBG the right to use their Personal Information for the sole purpose of administering the Contest, including contacting and announcing the Winner and coordinating the provision of the Prize.
- 5. In the event a selected entrant does not meet the eligibility requirements, then RBG has no obligation to award any prize.
