Public Works Department (PWD) has a requested three (3) quotations for this scope of work, one did not respond, but two (2) companies submitted bids.

In discussions with Life Long Learning (LLL) and PWD, this scope of work will be scheduled prior to the beginning of the school year.

LLL is agreeable to expend 100% of the cost (\$74,459.00) plus a 10% contingency fee (\$7,445.90) for a total of (\$81,904.90) in 2023 fiscal.

Due to the current LSK Expansion Project being completed, coordination is critical at this stage.

<u>AGENDA ITEM NO. 6a) – APPLICATION TO THE COMMUNITY TRUST –</u> POST-SECONDARY COMPUTER FUNDING (DIRECTOR OF LIFELONG LEARNING)

Director of Lifelong Learning noted in her Briefing Note that the Department of Lifelong Learning would like to create a Computer Loan Program for post-secondary students. In order to provide this Program to post-secondary students, funds in the approximate amount of \$50,000.00 (Fifty Thousand Dollars and Zero Cents) is necessary. We are therefore requesting approval to apply to the MNCFN Community Trust for this amount.

It is anticipated that approximately 25 post-secondary students will apply to receive a computer under a Computer Loan Program.

An agreement will be drafted which will provide the parameters under which the post-secondary students will loan a computer from the Department of Lifelong Learning.

AGENDA ITEM NO. 6b) – LLOYD S. KING ELEMENTARY SCHOOL – MOHAWK GARDEN MARKET QUOTE FOR APPROVAL (DIRECTOR OF LIFELONG LEARNING)

Director of Lifelong Learning noted in her Briefing Note that the Lifelong Learning Department is seeking approval from Chief and Council to approve the expenditure to provide a seating area and for soil and overseed to create a fresh grassy area at Lloyd S. King Elementary School to prepare the school for grand opening of the new spaces in September. The estimated quote for the materials and labour is \$15,980.00 (Fifteen Thousand Nine Hundred Eighty Dollars and Zero Cents).

The island in front of LSK has not been taken care of on a regular basis and we would like to retain the services of Mohawk Garden Market to replace and rejuvenate that area in anticipation of the grand opening of our new spaces in September.

Based on the above, we are seeking permission to enter into a contract with our preferred vendor, Mohawk Garden Market, in the amount of \$15,980.00 (Fifteen Thousand Nine Hundred Eighty Dollars and Zero Cents) which provides nursery and land goods for Lloyd S. King School.

It was noted that MCFN Members should be included in doing the landscaping. Councillor FS informed that the clean-up itself is a lot of work, and Executive Director of Operations added that there is a skill in planting.

Victoria Gray of the Communications Department noted in her Briefing Note that the Communications Department is looking to purchase merchandise to sell at the Three Fires Pow Wow and to later use as gifts for dignitaries, visitors, and other department events.

Merchandise levels are dwindling from last year's Pow Wow order. There are very few size options left in the medium to extra-large size range. We have very few notebooks and only a handful of bags left. If we do not order merchandise ASAP, we will have nothing to offer for Pow Wow. Communications has been quoted \$18,208.20 (not including exact freights, additional taxes or overages) from Talbot Marketing for the purchase of hoodies, T-shirts, ball caps, tote bags, frisbees and water bottles. The expense will be coded to Communications (100400).

Councillor VKJ noted in her Briefing Note that she is requesting to use the LSK baseball diamond and creating another baseball play area with bases in the soccer field area. At the same time, we would like to have access to the Splash Pad for these youth coming from across the six Mississauga Nations.

We will have coaches/volunteers from each community to chaperone the baseball youth. At the last baseball tournament in Curve Lake on July 22nd there were approximately 300+ participants, and we would have the same estimated participants for the upcoming tournament. Curve Lake and Alderville will be bringing two busses each from their communities.

We have been involved with the Jays Care Foundation last year and again this year. The six communities across the Mississauga Nation come together to host two tournaments. MCFN will be hosting the next tournament.

Councillor AS informed that hopefully the Splash Pad will be fixed, but we are waiting for Hydro One as this is a hydro issue.

Councillor VKJ stated that no budgets have been entered, and she (VKJ) was going to use dollars from the Pillar 4 Budget. She has applied to the Blue Jays Foundation, and if we get any dollars we will reimburse.

Councillor VKJ also questioned if we could get Auditors to come in and help bring the budgets and finances up to date. She reiterated that she is looking for the data entry to be entered.

Executive Director of Finances/HR reiterated that the budgets have not been approved.
