AGENDA ITEM NO. 6 – LLOYD S. KING EXPANSION – INSTALLATION OF ADDITIONAL SPEAKERS & CLASSROOM PANEL SPEAKER CHANGE (DIRECTOR OF LIFELONG LEARNING)

Director of Lifelong Learning noted that Council approved the installation of the PA system in the Lloyd S. King Elementary School (LSK) in March 2023. Upon installation, it became apparent that there were modifications needed for the school. The modifications consist of additional speakers, a classroom panel speaker change, and additional labour not anticipated in the initial quote. This quote is from Ewee-NS Inc. The amount of Ewee-NS Inc.'s quote with the add-ons is approximately \$15,801.62 (Fifteen Thousand Eight Hundred One Dollars and Sixty-Two Cents).

In order to have to stay up to date with our communications at LSK, it is recommended that the modifications be approved. The expenditure will be allocated to 500300-58600 and will come from the regular LSK budget. The Finance Verification is also attached for your reference. It is suggested that this additional expenditure be approved and that the quote be signed by the Executive Director of Operations.

AGENDA ITEM NO. 7 – EKWAAMJIGENANG CHILDREN'S CENTRE FUTURE USE (KK)

Executive Director of Operations noted that she is seeking Council confirmation regarding the future use of the Ekwaamjigenang Children's Centre.

As the LSK Expansion is nearing completion, the Community Well-Being and Jurisdictional Initiative (CWJI) Working Group is bringing forth the following recommendations for building use.

The CWJI Working Group informally struck to look at a plan to utilize the CWJI dollars received from Indigenous Services Canada. Overall, the dollars are to be used for Family Well-Being purposes, and retro-fitting is an eligible expense.

Separating the Social and Health Services has been part of the plan for some time. The group (EMT, Director of Social Services and Pillar 2 Lead) has met and has had two meetings with the Director of Public Works and our rep from Ontario First Nation Technical Services Corporation (OFNTSC).

Due to expenditure needs, we are formally recommending that the First Nation proceed with a design build process, and that OFNTSC lead the process. With regards to the occupants of the ECC building, we are strongly recommending the following:

- Director of Social Services
- Mental Health Team (3)
- Community Support Team (3)
- Community Resource Coordinator
- Family Support Team (3)
- Youth Group/After School Program Area (separate entrance)
- Kitchen, laundry, storage, lunch room, washrooms, reception
- Large Programming/Boardroom Style Area

Once Social Services moves from their existing space, recommendations will come forward regarding better utilization of the space at the current Social and Health Services building.

OFNTSC has recommended that MCFN proceed with a design build, which is a method of project delivery in which one entity works under a single contract with the project owner to provide design and construction services. As such, we would like Council confirmation that we can move ahead.

Gimaa Stacey questioned if this is a long term goal. Executive Director of Operations answered yes, but also the health wing would serve as a place for doctors and other health practitioners who will be on site when necessary.

The Community Well-Being and Jurisdictional Initiative (CWJI) Working Group consists of the Executive Director of Intergovernmental Affairs, Executive Director of Finance/HR, Executive Director of Operations and PW Director.

<u>AGENDA ITEM NO. 9 – MASS MESSAGING SERVICE (COMMUNICATIONS & ENGAGEMENT LEAD)</u>

Communications and Engagement Lead noted in her Briefing Note that Rogers Mass Messaging service provides enterprises with tools to send and receive multi-channel bulk messaging across: SMS, MMS, Voice calls, to mobile users.

Features include sending an email to any device - e-mail, mobile, fixed telephone, and SMS your regular E-mail client. You can send an email to your customer's home phone. Their phone will ring, and a text-to-speech engine will play the text to them over the phone.

Communications and Engagement Lead sat in on a presentation with Rogers and indicated MCFN may be interested in moving forward and requested a quote (attached).

Rogers confirmed 1 message sent to 500 contacts would count as 500 messages. The recommended plan now is the "Bronze Plan" at \$125.00 a month, to come out of Communications Budget – this would include 5 messages per month to be safe.

Communications Department has already received access to test the platform and to send out a test message.

Notice will be provided to the Community to ensure these messages are not deleted and marked as spam. They will have the option to unsubscribe from alerts. They can also reach out if their number was not contacted.

Lands and Membership has a sheet of contact numbers, and we will work with them on who did not consent to be contacted.

These alerts can be anything from Community Safety, to event reminders.

AGENDA ITEM NO. 10 - ANIMAL CONTROL SERVICES & THE NIAGARA SPCA CONTRACT (KK)

Executive Director of Operations noted in her Briefing Note that she is seeking Council direction on Animal Control Services. MCFN has a general Animal Control Agreement with Niagara SPCA.

Executive Director of Operations informed that there have been some recent issues with the ability of our Members to access support service when they call the designated support number. The LM Director called this number and was not happy with the response.

Executive Director of Operations requested a meeting with the Executive Director of the Niagara SPCA, John Greer. During the discussion, we went over the agreement and we agreed that the wording does indicate that the service provider would provide services relating to animal control matters, nuisances and emergency situations. He did advise that there was an overall caution regarding removing animals from the Community, as charges would incur for the pet owners, if applicable.

Executive Director of Operations shared that many calls would be related to nuisance animals, usually who have a history of being a nuisance. We also talked about raccoons, opossum and chipmunks/squirrels and it was explained that these animals are deemed wildlife and would fall outside of their realm. They do however, offer a Sick and Injured Program that could assist with ill animals that need to be humanely euthanized.

We discussed that it would beneficial if he comes to a Council meeting to discuss their services in detail, and to provide an opportunity for Council to discuss needs.

DIRECTION NO. 7

That the Mississaugas of the Credit First Nation (MCFN) Infrastructure & Environmental Stewardship Council directs the Executive Director of Operations to set up a meeting with John Greer who is the Executive Director of the Niagara SPCA, and LM Director, Councillors Fawn Sault and Andrea King, and will include further discussion on Animal Control Services for MCFN.

AGENDA ITEM NO. 11 - KNOX PRESBYSTERIAN CHURCH 16 - OAKVILLE (EF)

Councillor EF noted that an invitation has been received from the Knox Presbyterian Church 16, 1150 Dundas Street West, Oakville, ON, L6H 7C9 to participate in Reconciliation – Truth and Reconciliation Calls to Action.

The members of the Knox Church 16 recognizes the MCFN were on this land and the members have reached out to the MCFN to participate in the September 23, 2023, event. A booth has

been offered (at no cost) for Members of the MCFN to share information, host a food booth, dancing, drumming etc.

It is noted that September 23, 2023 is the date for the Annual Recognition Awards Banquet.
