AGENDA ITEM NO. 5 – LETTER OF SUPPORT REQUEST – GUELPH PROPOSED PARK (EF)

Councillor EF noted in her Briefing Note that Councillor FS and she (EF) met with Brian Skerrett, on November 27, 2023 to discuss his request for a letter of support for an Urban Park in Guelph. Brian is also requesting a letter of support to move forward with illustrating art work, poetry etc. that was created by the inmates at the Guelph Reformatory.

While incarcerated at the Guelph Reformatory, First Nation inmates created art murals on the basement walls and produced booklets of poems. The inmates also had a sweat lodge for ceremonies for a short period of time, until it was ruled unsafe.

Only one former inmate, who contributed to the art at the Reformatory and provided input on the book of poems, remains alive, and has given his permission to Mr. Skerrett to use the book of poems for his project.

Two copies of the booklets have been provided to MCFN.

DIRECTION NO. 2

That the Mississaugas of the Credit First Nation (MCFN) Financial Planning & Fiscal Oversight Council directs Councillor Erma Ferrell to give the booklets (of poems) that were produced by inmates in the former Guelph Reformatory to the Traditional Knowledge and Land Use Coordinator (Darrin Wybenga) for safekeeping.

AGENDA ITEM NO. 6 – COUNCIL HOUSE RENOVATION COMMITTEE PROJECT PLANS (KK)

Executive Director of Operations is bringing back some options on how to move forward with the Council House Renovation Project reporting requirements and a succession plan in the event that Councillor AS is not successful in the upcoming election.

March 31, 2024 is the deadline when the Project should be completed.

Executive Director of Operations is recommending that a short-term purchase of service contract person be hired to ensure the administrative continuity of the Council House Renovation Project. Further, dollars from the Enterprise Fund can be used.

It is being recommended that the Policy be approved, as Council has reviewed it in its entirety three times, and once a Legal Opinion is obtained about the Code of Conduct, that it return to the Council Table if the current process puts the First Nation in a liability position.
