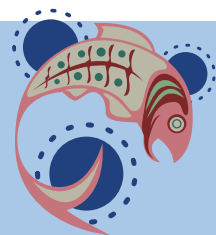
MCFN runs 23rd annual school hockey tournament

Aaniin kina-weyaa (hello everyone),

First an introduction for those of you that do not know me. My name is Fawn Sault. I am a Councillor and the Lead for Pillar 3, Environment, Sustainability and Stewardship. I am a single mother of a 19-year-old son. I was born and raised in Detroit, Michigan. I built my home here on reserve approximately 10 years ago and have lived in the community for almost 19 years.

My educational background: Environmental Technician Diploma, Adult Indigenous Education Certificate and I am currently studying Horticulture and Landscape Design at the University of Guelph.

I have worked as the Environmental Technician in Community Health, in Lands, Membership and Research (LMR) as a Field Liaison (not what it was called at the time), in LMR as the Geo-tech assistant (which was basically consultation and accommodation), and in the Department of Consultation and Accommodation since it was created as the Consultation Manager.

Councillor Jesse Herkimer Community Update

As a first-time member of council, I have endeavored to hit the ground running and throw myself into advocating for the Nation with enthusiasm and empathy. I have been directed to the board of MCBC, meeting with them nearly every Tuesday. Board discussions talk about building the business corporation through partnerships with major entities within our treaty territory. My long-term goal as a board member is to bring financial security to our nation. This will help support our programming, building elder care, infrastructure, job creation, along with many other beneficial needs to our people. As a member of this Nation, it is important to me to see our people prosper. Our community members deserve a bright future where we all can flourish.

I have also met with DOCA several times. I will continue to stand behind DOCA while giving them

political backing with our Treaty Rights. I look forward to working with DOCA implementing our treaty rights within municipalities and corporations working in our territory.

MCFN council has directed me to sit on the board of the Niagara Region Limited Partnership (NRLP). Hydro One, Six Nations of the Grand River Development Corporation (SNGR) and MCFN have a commercial partnership known as the NRLP. The limited partnership wholly owns a 76-kilometre, dual-circuit, 230 kilovolt (kV) line running between the Allanburg Transmission Station near Niagara Falls and Hydro One's Middleport Transmission Station, west of Caledonia. The line has the capacity to transmit 800 Megawatts (MW) of clean, renewable energy. There is a meeting in mid-March to discuss the line, its functions and our partnership in it.

I have been working with may-

ors, including Haldimand Mayor Shelly Ann Bently to discuss the drainage issues at the Industrial Park. Currently, rainwater drains into the Industrial Park and it's time to solve this issue.

I also met with the Mayor of Brampton, Patrick Brown with MCBC to discuss Treaty Rights and future partnerships that could be established. As I see the progress that's already been made I am positive that the Nation has a bright future. 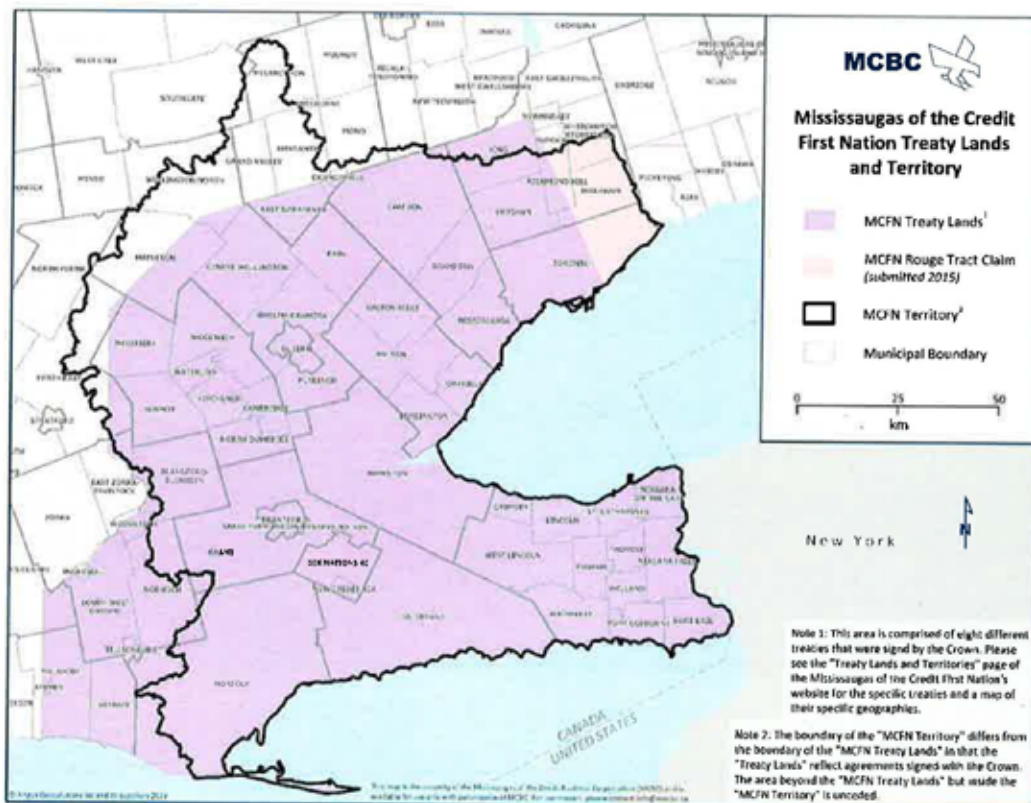

Our primary team placed 3rd with three losses and a tie. A highlight for them was going to overtime and a shootout with no goalie, but players jumping in net to defend their net.

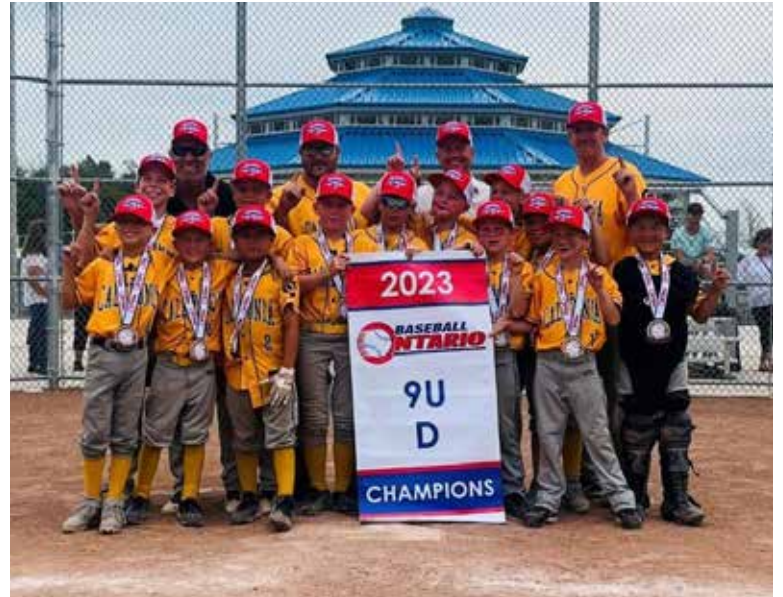
Our junior team placed 4th, they didn't come up with a win during the tournament but all played very well and some even helped sing at the drum during opening ceremonies.

Housing Repair/Renovation & Sanitation (HRRS) and/or CMHC/RRAP Program

This is a program to improve the quality of your home and to address all MANDATORY Health, Safety, & Structural deficiencies in and outside of your home.

HRRS applications can be picked up at the Housing office (agimaw gamig Building-Administration) or you may call the Housing Assistant, Amanda LaForme at 905-768-1133 ext.225 to request an application be mailed to you or emailing Amanda.LaForme@mncfn.ca to have an application e-mailed to you.

Applications are to be returned to the Housing Office on or before and no later than April 1, 2024 – no later than 4:30 p.m.

Once the deadline of APRIL 1, 2024 has passed, and all applications submitted:

- ❖ Inspections will be set up to inspect your home identifying not only the repairs you request but also to ensure that all Health, Safety, Structural deficiencies are addressed.
- ❖ A specification report will be drawn up and you will be required to attend the Housing office to view the specification report or the report will be mailed directly to you.
- ❖ After review of the Specification Report, you will sign off of the Specification Report that you are in agreement with all listed items.
- ❖ You then will be required to obtain at least 2 estimates per item listed on the specification report.
- ❖ Housing Staff, based on Program criteria will determine which program applicant qualifies for (CMHC/RRAP Program and/or the MNCFN HRRS Program or both)

***Applications submitted after the deadline date will be dealt with on funding availability.**

Discretionary/Cosmetic items can only be completed if dollars are available and once all Mandatory Health, Safety, & Structural items have been addressed for all applicants.

For Emergency: (addressed as situations arise)

>If heating/plumbing, or electrical issues arise, a service man **MUST BE CONTACTED FIRST** to identify the problem, and once **THE PROBLEM IS IDENTIFIED**, an inspector is sent to verify the situation, specifications will be drawn up, and 1 estimate submitted.

>Public Works Department may deem 2 estimates are necessary if estimate submitted appears too high or too low.





>Also, a letter from your insurance company must be provided stating that the repair is not covered by your insurance company.

Note: Proof of income, Proof of land ownership where house is situated, and house insurance (copy of policy) is required at time of application.

HOUSING NEW PROGRAM

Housing New applications are ongoing and can be picked up anytime throughout the year. You may attend the Housing Office located in the agimaw gamig building (Administration) to obtain an application or you may request to have a Housing-New application mailed to you by calling 905-768-1133, Ext. 242 or emailing Colette.Webb@mncfn.ca to have an application emailed to you.

Once your housing application has been submitted and checked to ensure that the application has been filled out properly, signed and dated you will be placed on the housing new list.

Thereafter, each and every year, you will receive notification by letter of your placement number on the housing list as you move up the list.

There are approximately 115 individuals listed on the housing new list.

A message from Technical Resource Support:

As the snow begins to melt, leaks or floods may become a problem. Check your home for moisture.

Here are a few tips to deal with moisture or water:

- Dry or remove water damaged items within the first 48 hours to reduce the risk of mould growth
 - Repair leaks right away
 - Dry the floor, walls, furniture and other wet items – throw away items that can't be dried

**Mississaugas of the Credit First Nation (MCFN) Ekwaamjigenang Children’s Centre
Enrollment and Waiting List Eligibility Criteria, Procedure and Application Form**

Children are placed on the waiting list in accordance with the Priority Requirements Chart below and then by the date and/or time of the completed forms received at ECC. When a space becomes available, the ECC Supervisor or Assistant Supervisor will contact the family.

Families will be given one week to state their intent in regard to that space. If the space is confirmed and accepted, the Supervisor or Assistant Supervisor will move forward with completing the application process, orientation and payment arrangements.

If the family chooses not to accept the available space, the application will be placed at the bottom of the relevant priority list. A space declined 3 times within 12 months from the first offer will be removed from the waitlist.

ECC has 3 emergency child care spaces for MCFN families. These spaces are available as needed for emergency child care only and based on centre capacity and required enrollment documents per the CCEYA, 2014. For more information, please contact the Centre Supervisor or the Early Years Administrator.

ECC respects the privacy and confidentiality of the children on the waitlist. Information will only be shared with the parent/guardian on the application form. The applicant is responsible for keeping up to-date on the status of their application’s position on the waitlist. The applicant must ensure that their contact information is accurate. To check the status of an application, please reach out to the ECC Supervisor via email at shannon.king@mncfn.ca or by phone call at 905 768 5036

**Children enrolled under priority B-D are enrolled on a contractual basis. Should there be a priority A who submits a *Waiting List Application Form* for a space taken by a priority B-D they would be given not less than 3 months’ notice of termination.

*To a maximum age group capacity of 30%; available spaces beyond the 30% capacity would be offered on a contractual basic.

Birth

In order for your child to be registered on the Mississaugas of the Credit membership list you must register the birth with Indigenous Services Canada (ISC). You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Only those entitled to registration on the MCFN membership list will be registered. ISC will notify you if your child is not eligible for registration.

Marriage

To register your marriage you must submit a request for amendment form, a copy of your marriage certificate and copies of your identification showing your married name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Divorce

To register your divorce you must submit a request for amendment form, a copy of your divorce certificate and copies of your identification showing your maiden name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Name Change

To register a name change you must submit a request for amendment form, a copy of the name change certificate and copies of your identification showing your new name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Death

When a Mississaugas of the Credit member passes away the death must be registered with Indigenous Services Canada. If a death is not reported the deceased individual will remain on the MCFN membership list. You can submit a death certificate to the MCFN Lands & Membership Dept. or to ISC.

Overview of Sections 6(1) and 6(2) of the Indian Act



6(1)(a) - Entitlement of person who was registered or entitled to be registered on or before April 17, 1985

6(1)(a.1) - Reinstatement of individuals whose names were omitted or deleted from the Indian Register, or a band list prior to September 4, 1951.

6(1)(a.2) - that person meets the following conditions:

(i) they were born female during the period beginning on September 4, 1951 and ending on April 16, 1985 and their parents were not married to each other at the time of the birth,

(ii) their father was at the time of that person's birth entitled to be registered or, if he was no longer living at that time, was at the time of death entitled to be registered, and

(iii) their mother was not at the time of that person's birth entitled to be registered;

6(1)(a.3) - that person is a direct descendant of a person who is, was or would have been entitled to be registered under paragraph (a.1) or (a.2) and

(i) they were born before April 17, 1985, whether or not their parents were married to each other at the time of the birth, or

(ii) they were born after April 16, 1985 and their parents were married to each other at any time before April 17, 1985;

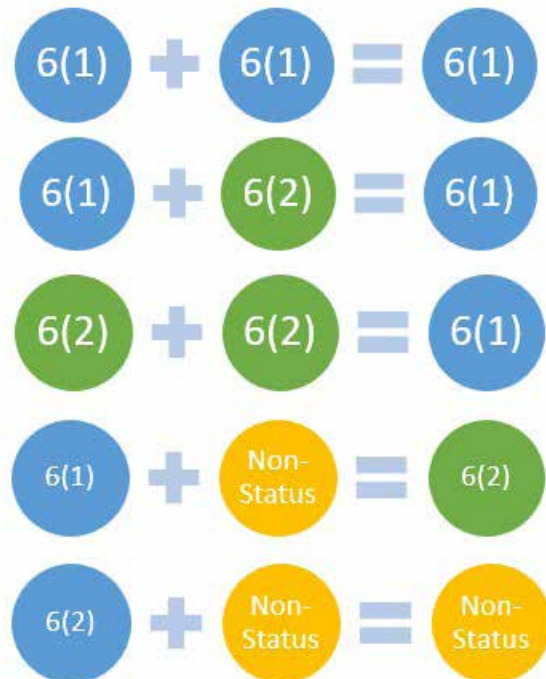
6(1)(b) - Entitlement for individuals who are members of a group declared to be a Band after April 17, 1985

6(1)(d) - Reinstatement for an individual who was enfranchised by voluntary application prior to April 17, 1985

6(1)(e) - Reinstatement for an individual that was enfranchised prior to September 4, 1951 for reasons of living abroad for 5 or more years without the consent of the Superintendent General or becoming ministers, doctors, lawyers ("professionals" only until 1920)

6(1)(f) - Entitlement for children with both parents entitled to registration

6(2) - Entitlement for children when only one parent is entitled to registration under 6(1) and the other parent is not entitled to registration.

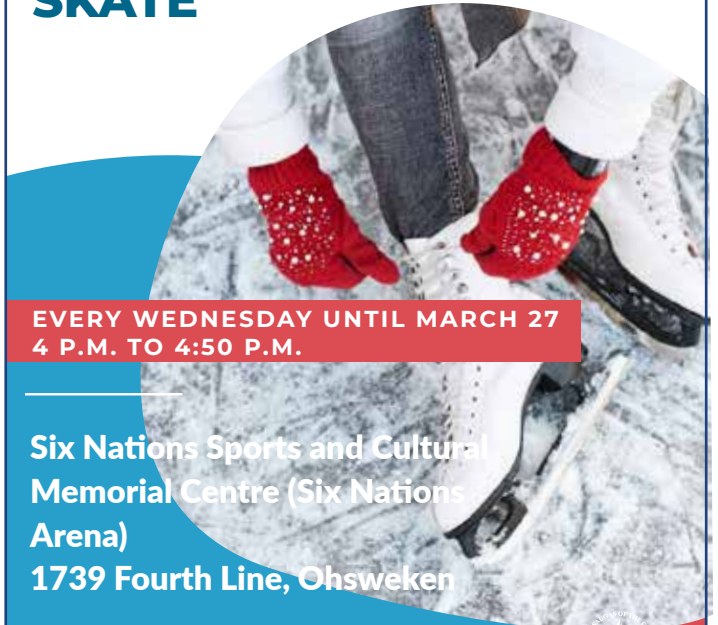

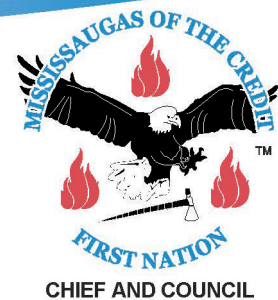
