OGIMAA KWE CLAIRE SAULT

The organizational review is well under way. The tentative date for the consultants to make recommendations is May 12, 2024.

The purpose of the organizational review:
Currently MCFN – 220 employees

- Bring clarity to address complaints from staff and community
- NOT intended to reduce staff
- Involve the perspective of the Directors, Managers, Supervisors & Staff
- Identify inefficiencies
- Identify capacity (education & skills) deficiencies for current workloads
- Recommendations for accountability
- Documented path forward with recommendations

As you know, with the current reporting structure, the Council has 3 people that report directly to the Council. With the resignation of the Executive Director of Operations in March and Executive Director of Intergovernmental Affairs in February, we had to act quickly to fill these key positions. Unfortunately, these positions should have required a 30-day notice, but our current policy only called for a 2-week resignation notice. Which left us in a position to contract two interim candidates to quickly fill these roles. Please welcome Warren Sault as the interim EDO and Richard Karsseboom as the interim EDIA both on a six-month contract.

February and March proved to be busy months. I've had several speaking engagements and productive meetings. The First Nation has had a healthy and fruitful relationship with Massey College. Councillor Ferrell and I spent a few hours getting acquainted with their professional team. I was invited by Premier Ford to attend the Mississauga Board of Trade breakfast meeting where he announced his update and the focus of the local area of Mississauga. Networking is always important at these events, so fruitful connections came out of that meeting. I had a meeting with MP, Lloyd Longsfield in



Guelph. My agenda was to discuss MCFN's participation in the National Parks initiative by the federal government. There is a beautiful property

in Guelph that used to be a reformatory that closed 25 years ago. It's one of the locations being considered for a national park. I wanted to make sure we had a significant presence throughout the process of working with all levels of government on this project.

I was invited to meet Her Honour, Lieutenant Governor of Ontario, Edith Dumont. This was a pleasant visit and an opportunity to discuss priorities and to seek her support for our external priorities in Toronto. She also asked that our First Nation staff train her 14 staff to better understand the history of MCFN. I suggested that we include some cultural and protocol training and some understanding of the First Nations political structures as well.

My recent meeting with MPP, Mike Schreiner in Guelph proved to be fruitful as well. Councillor Larry Sault and I conveyed the First Nations position on the Metis issue among other things. On March 4th the Negotiations team had a meeting with the Acting Deputy Minister, Candice Telfor, Ontario Ministry of Indigenous Affairs to get a status update on Rouge River Valley claim. This turned out to be non-committal on her part to provide a timeline but regardless, the Team left hopeful of movement forward sooner than anticipated.

MCFN Council Priorities Con't

Since TRC, the Chief and Council's responsibilities have increased dramatically and most First Nation did not keep up with the capacity needed to take on this increased workload. There is still much work to be done and plenty of opportunities. MCFN staff are doing our best with what capacity we do have to execute on some of these opportunities that came as a result of TRC implementation. But we need a lot more strategic thought into the larger picture and recognizing what opportunities are priorities for MCFN to pursue. Fortunately for MCFN, we'll have a much better perspective at the end of the Org Review that should help guide some of these decisions on capacity building. The Council is working diligently to correct some of the external messaging that companies use as their land acknowledgement. We have several companies that are willing to make corrections to their acknowledgement that reflect truth and clarity. The demands are high for speaking engagements that include welcoming remarks, land acknowledgements or a motivating perspective on the topic and more important is what benefit it will have to the First Nation. We are all making a conscious effort to state we are the sole treaty holder at every opportunity we get. Since January, I've done 7 of these speaking events that are important to elevate MCFN status. The Council has been super about stepping up and helping with these speaking events.

We had our community meeting on March 9, 2024, to discuss the roll out and plan for the term. It's been a challenge not having our financial house in order. To date, with larger initiatives such as the Org Review, we've applied for various grants to pursue some of these priorities.

Below is the priorities I agreed to pursue during the 23/25 term:

- Preparing Youth & Younger Generation For Council & Leadership
- Election Code Passed

- Resolving Issue About The Sale of Cannabis
 - Improving Structural & Communication – Internal & External Faster Speed
 - Start the Process – Find Capital To Build New Administration Building
 - Messaging external to the First Nation & Treaty Territory
 - Follow Through with MOU's – Assess & Evaluate First
 - Governance & Financial Practices – In Line With Priorities
 - Financial Literacy – Across The Organization
- Collectively the Council will work on:
- Constitution – Legislative Branch, More Consultation
 - Election Law – Consultation
 - Cannabis Law – Resolve once and for all
 - Residency Law – Include membership
 - Dog Law – Include membership
- Transparency and bringing a better financial understanding to you as members is an important priority for me and I will do so, once we have concrete numbers to present.

This month has been a productive time for Pillar 1 – Inclusive Prosperity, Economic Growth and Job Creation. I have continued to support MCBC with their efforts toward economic growth through utilizing our Treaty Rights in our traditional territory. I have also supported DOCA through political advocacy with municipalities in our Treaty Territory; specifically looking toward accommodations from municipalities for development permits within the territory. Members of our council met with Haldimand County and members of their team to discuss ongoing issues such as drainage, road along with other infrastructure issues we are having. It was a productive first encounter with the new Chief and Council. We

hope to continue building our relationship through further working meetings. Update on an old project that was discontinued. The Lake Erie Connector is up and running through a new company NextEra who has acquired the project to bring it back online. The Lake Erie Connector is a electricity transfer station between Nanticoke, Ontario and Erie, Pennsylvania. We're working on an MOU and NDA at this time. 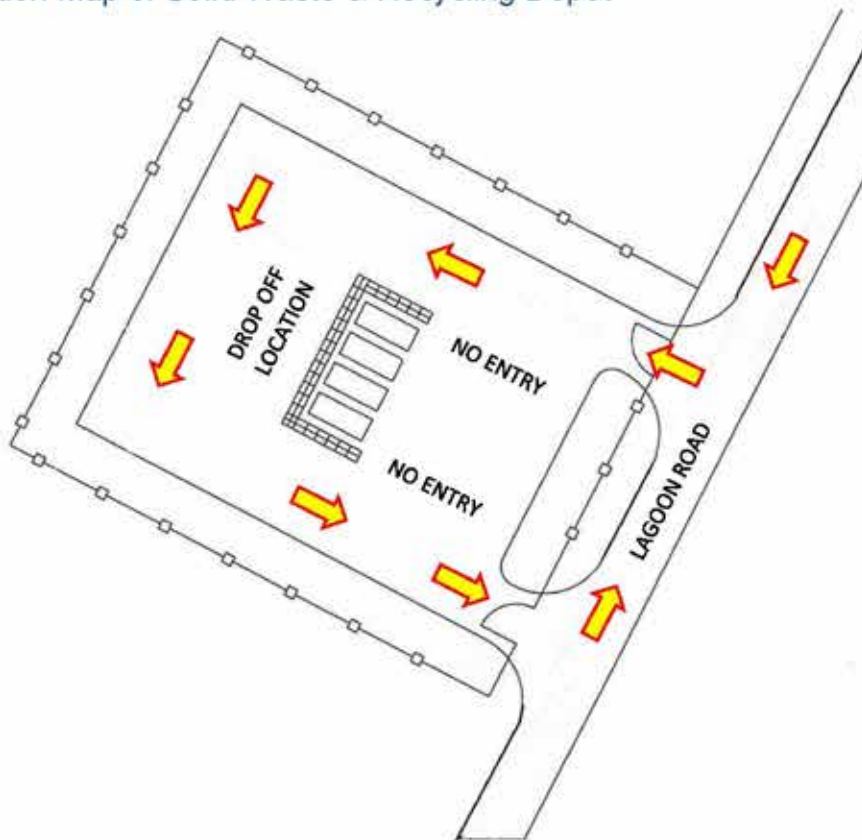

COMMUNITY CLEAN-UP 2024

SOLID WASTE & RECYCLING

DEPOT



MCFN Membership Only:

Public Works Department (PWD) is conducting our twice-yearly clean up event which occurs in April and October. Details of this April's event will be as follows:

1. Garbage bags (5 bags per bundle) & one (1) pair of gloves for each household participating will be available for pick-up by contacting Jeremy Tapper (519) 732-3058. Filled garbage bags can be placed at roadside for PWD staff to collect during morning check of road duties.
2. All PW Staff will split shifts as follows:
 - a. PWD will alternate staff starting April 15th through to April 19th to control access and direct members to appropriate bin for drop off (9:00am to 6:00pm)
 - b. PWD will alternate staff on April 20, 2024, to control access and direct members to appropriate bin drop off (9:00am to 3:00pm)
 - c. **CLOSED Sunday April 21, 2024**
 - d. PWD will alternate staff starting April 22nd through to April 26th to control access and direct members to appropriate bin for drop off (9:00am to 6:00pm)
 - e. PWD will alternate staff on April 27, 2024, to control access and direct members to appropriate bin drop off (9:00am to 3:00pm)
 - f. **CLOSED Sunday April 28, 2024**
3. **All waste is to be pre-sorted for a seamless drop off upon entering depot.**
4. All PWD staff will have high vis safety vests, gloves, and footwear at drop off location.
5. **MCFN members will be required to show their status card prior to entry, will remain in their vehicles until they are directed to the proper bin for unloading of waste.**
6. **There will be no congregating of people during the drop off (monitored by all staff on site)**
7. **MCFN members will be directed to the designated bin and will unload debris quickly to reduce wait times of others.**
8. **PWD staff will be present to organize drop offs and control of vehicular traffic flow in/out of drop off location.**
9. **Drop off location will only be at Solid Waste & Recycling Depot along Lagoon Road location.**
10. PWD to arrange for two (2) forty-yard bins (**regular household waste**)
11. PWD to arrange for one (1) forty-yard bin (**scrap metal**)
12. PWD to arrange for one (1) forty-yard bin with no restrictions (**construction debris**)
13. PWD Staff will have the backhoe during this event to compress debris in preparation for transporting and emptying. Each bin will be emptied weekly in preparation for the weekend drop offs by band members.

From the Department of Lifelong Learning April 2024 Updates

We hope all students and Lloyd S. King Elementary School all had an enjoyable and restful March Break.

Here are a few dates to keep in mind:

March 29th-Good Friday. Statutory Holiday

April 1st - Easter Monday holiday for students who attend Grand Erie District School Board and Brant Haldimand Norfolk Catholic District School Board schools, and Polytechnic STEAM Academy.

April 1st - Lloyd S. King Elementary School is open
April 8th - Professional Development Day for Lloyd S. King Elementary School staff no classes for students

The deadline for Covid-19 Reimbursement is Sunday March 31, 2024. If your child is in elementary and/or high school and you purchased equipment or tutoring you can send in your receipts for reimbursement. This reimbursement opportunity is available for members both on and off First Nation Location 40A.

Some high school students have not sent in their report cards. There are also quite a few who have not filled out the application for the allowances that will be starting soon. Post-Secondary Did you know...

- McMaster University is launching a master's program in Indigenous Studies to give undergraduate students in the field the opportunity to continue their studies at a higher level.
- The Northern Alberta Institute of Technology and the University of Regina have established a transfer agreement that students who complete NAIT's Personal Fitness Trainer program can enrol in the third year of URegina's Bachelor of Kinesiology in Human Kinetics program.
- Cégep de Drummondville (Quebec) will offer a double diploma program in education and criminology. The diploma will take four years to complete, with students beginning in one program, and the second program integrated into the curriculum in the third year onwards.
- The George Brown College Prosthetic-Orthotic Technician Program is the only technical training program in Prosthetics and Orthotics in Canada. It is a two-year diploma program which accepts twenty-five students each year.

Due to the specialization and unique characteristics of this profession, it is recommended that those who wish to enter this profession and program, visit rehabilitation and orthotic and prosthetic facilities to see the types of devices made and the special skills required to fabricate and fit them.

Interested in applying for funding for one of these programs, or another more suited to you? The online application form is available under Lifelong Learning on the MCFN website.

You will need the school information to apply-if you have not been accepted yet, put in the school and program you want the most.

Department of Lifelong Learning Updates cont.

That information can be modified to the one you ultimately choose to go to.

Did you apply for all the semesters in the Academic year? (Currently programs starting in April of 2024 to March 31, 2025) When your application is reviewed, it is opened up to allow you to upload the information needed to make your application complete.

Your status card, direct deposit information, and the Application Declaration, including the Consent to Share info and the Financial Recovery Contract. These three need to be signed and uploaded with each application, once for each Academic year. Indigenous Services Canada requires a new application each Academic year. Each semester also requires grades/schedule as they occur, and of course the letter from the school offering the position in a program or a copy of their acceptance of Your acceptance.

Finally, the Post Secondary Advisor and the staff of Lifelong Learning are your friends. Contact them with questions, for advice on next steps, help with program choices, options and direction regarding personal life and its inevitable effects on your education journey.

Student Spotlight

Name, program, school. In residence?

My name is Brianna Rowe and I am in my 3rd year at the University of Toronto Faculty of Law. I graduated from my undergraduate degree with honours from the University of Waterloo, I have a Bachelor of Arts, majoring in Legal Studies with a minor in Psychology. I lived in residence for my first year UW, and then with my parents for the next 3 years, and since 2021, I've lived in my own apartment off campus. **What was your biggest surprise?**

Going from high school to university, how lonely it can be. I didn't make a single friend at the University of Waterloo. I was very get in and get out. I could be sitting in a class of 200 people and know no one. It was scary, coming from a place where everyone had known each other since kindergarten. Alternatively, going from my undergrad to law school, how school doesn't have to be lonely. I was lucky enough to meet one of my best friends the day of orientation and knowing people in the classes I take, having people to study with is such a better experience than I've ever had in a learning environment.

What has your journey been like?

Not always the easiest. I didn't take university very seriously in my first year and didn't do well, even failed a course. Then, I started to hunker down, got better at studying the way universities want you to and improved my marks. I worked a part time job throughout my undergrad to help organise my time. I took the Law School Admissions Test in January 2021, during COVID, got a decent mark, got accepted into 3 schools and chose the first one that chose me. During Law School, I've been focused on my studies from September - April every year. During the summers, I've worked at a legal aid clinic in their family law department and with the government more recently. I've taken classes from across all focuses of law, just to see what interests me, and now I'm graduating this summer.

Have some advice for others?

Reach out to people. Mentorship, for me, has been key. I love talking to people who were in my place and seeing the paths they took, the advice they can give and advice they got that maybe didn't work. People love talking about themselves and what they've done so it's not as big of a risk to reach out to people who are where you want to go than you think.

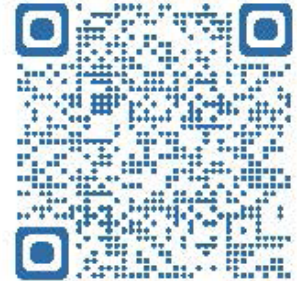
Where might your course take you in your future?

I will be writing the Bar Exams this June around when I graduate. Then, in July, I start my articling term at the Office of the Children's Lawyer, which is a government office that represents the interests of children in certain court proceedings. After a 10 month articling term, I will then be called to the bar next June and will officially be able to call myself an attorney. After that, I'm unsure of where I will be. I will hopefully be able to work for an Indigenous law firm, helping Indigenous governments form their own child welfare legislation but, who knows?

Wait List Eligibility Criteria and Procedure

The Waiting List application form is available through the MCFN website or at the ECC office, or by emailing your request to shannon.king@mncfn.ca or Katharine.brown@mncfn.ca for an electronic copy.

There is no charge for the waiting list application.

Children are placed on the waiting list in accordance with the Priority Requirements Chart below and then by the date and/or time of the completed forms received at ECC. When a space becomes available, the ECC Supervisor or Assistant Supervisor will contact the family.

Families will be given one week to state their intent in regard to that space. If the space is confirmed and accepted, the Supervisor or Assistant Supervisor will move forward with completing the application process, orientation and payment arrangements.

If the family chooses not to accept the available space, the application will be placed at the bottom of the relevant priority list. A space declined 3 times within 12 months from the first offer will be removed from the waitlist.

ECC respects the privacy and confidentiality of the children on the waitlist. Information will only be shared with the parent/guardian on the application form. The applicant is responsible for keeping up-to-date on the status of their application's position on the waitlist. The applicant must ensure that their contact information is accurate. Birth

In order for your child to be registered on the Mississaugas of the Credit membership list you must register the birth with Indigenous Services Canada (ISC). You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Only those entitled to registration on the MCFN membership list will be registered. ISC will notify you if your child is not eligible for registration.

Marriage

To register your marriage you must submit a request for amendment form, a copy of your marriage certificate and copies of your identification showing your married name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Divorce

To register your divorce you must submit a request for amendment form, a copy of your divorce certificate and copies of your identification showing your maiden name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Name Change

To register a name change you must submit a request for amendment form, a copy of the name change certificate and copies of your identification showing your new name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Death

When a Mississaugas of the Credit member passes away the death must be registered with Indigenous Services Canada. If a death is not reported the deceased individual will remain on the MCFN membership list. You can submit a death certificate to the MCFN Lands & Membership Dept. or to ISC.

Overview of Sections 6(1) and 6(2) of the Indian Act



6(1)(a) - Entitlement of person who was registered or entitled to be registered on or before April 17, 1985

6(1)(a.1) - Reinstatement of individuals whose names were omitted or deleted from the Indian Register, or a band list prior to September 4, 1951.

6(1)(a.2) - that person meets the following conditions:

(i) they were born female during the period beginning on September 4, 1951 and ending on April 16, 1985 and their parents were not married to each other at the time of the birth,

(ii) their father was at the time of that person's birth entitled to be registered or, if he was no longer living at that time, was at the time of death entitled to be registered, and

(iii) their mother was not at the time of that person's birth entitled to be registered;

6(1)(a.3) - that person is a direct descendant of a person who is, was or would have been entitled to be registered under paragraph (a.1) or (a.2) and

(i) they were born before April 17, 1985, whether or not their parents were married to each other at the time of the birth, or

(ii) they were born after April 16, 1985 and their parents were married to each other at any time before April 17, 1985;

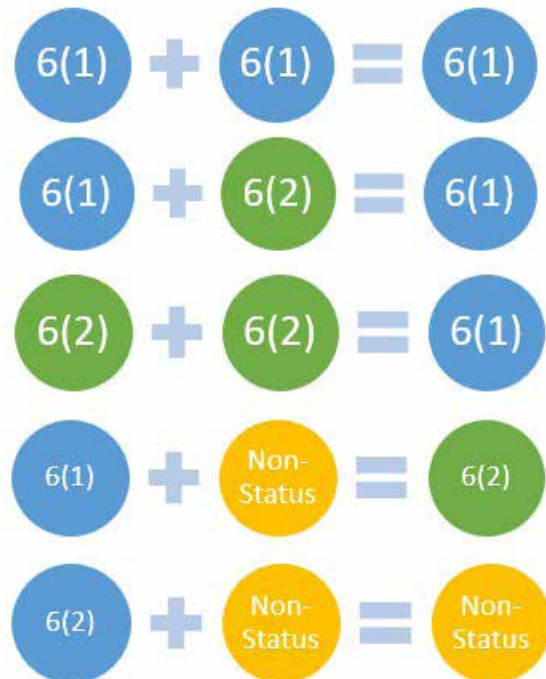
6(1)(b) - Entitlement for individuals who are members of a group declared to be a Band after April 17, 1985

6(1)(d) - Reinstatement for an individual who was enfranchised by voluntary application prior to April 17, 1985

6(1)(e) - Reinstatement for an individual that was enfranchised prior to September 4, 1951 for reasons of living abroad for 5 or more years without the consent of the Superintendent General or becoming ministers, doctors, lawyers ("professionals" only until 1920)

6(1)(f) - Entitlement for children with both parents entitled to registration

6(2) - Entitlement for children when only one parent is entitled to registration under 6(1) and the other parent is not entitled to registration.
