Rod Leclair provided the OPP Monthly Report for March 2024.

Councillor EF had a concern regarding domestic disputes. She stated that we need something to encourage Members to come forward with their complaints. Rod answered yes, something can be done. Councillor LM added that she would provide all the information to the OPP regarding the programs that MCFN Social Services Department has.

### AGENDA ITEM NO. 7 – TRAVEL EXPENSES FOR COUNCIL 2024-2025 (EF)

Ogimaa-Kwe and Council acknowledged the Report from Councillor EF as an FYI. Each will follow up with (his/her) Pillar.

### AGENDA ITEM NO. 8 – TAXES PAID ON THE KUYPER PROPERTY (EF)

Councillor EF noted in her Briefing Note that on December 5, 2023, she submitted a Briefing Note to the MCFN Chief and Council to discuss the total amount of taxes paid on the property formerly known as the Kuyper Property located at 4065 Hwy 6, Hagersville. On.

During her search of the Property Taxes paid on 4065 Hwy 6, Hagersville, she was able to obtain the amount from an employee of the Haldimand County Administration Office.

The original intent was to send a letter to the Federal Government requesting all funding paid to Haldimand County for property tax be returned to the Mississaugas of the Credit First Nation.

On December 5, 2023, the former Executive Director of the Governance Department stated she would follow up on trying to obtain the total cost of taxes paid. The former Executive Director resigned and her last day was February 13, 2024.

Councillor EF is of the understanding the information on the taxes was forwarded to the A/SED Director by an employee of Haldimand County.

Councillor EF followed up with the MCFN A/SED Director and was informed the employee at Haldimand County stated she/he would have to manually go through file boxes to locate this information.

It does not appear that we will obtain all of the information we require from Haldimand on the property taxes paid by MCFN.

Is it possible to write a letter to Canada Revenue and obtain this information?

There is a possibility the Federal Government may not reimburse the MCFN for the property taxes paid while waiting for the Addition to Reserve to be completed, but a letter to the Federal Government is a possibility.

## AGENDA ITEM NO. 9 – TAXES PAID BY MCFN TO HALDIMAND COUNTY ON THE PROPERTY AT 4065 HWY 6 (EF)

This item has been deleted as it was dealt with in Agenda Item No. 8 above.

### AGENDA ITEM NO. 10 – 4065 HWY 6 – BUILDING RENOVATION AND EVALUATION (EF)

Councillor EF noted in her Briefing Note that in the 2019-2020 fiscal year, a budget line was included for the possible renovation of the buildings at 4065 Hwy 6 behind the Duty of Consultation and Accommodation Department (DOCA).

Funding was allotted to have the buildings at 4065 Hwy 6 assessed by the Ontario First Nations Technical Service Corporation, <a href="https://www.ofntsc.org/">https://www.ofntsc.org/</a> to provide a report on the buildings behind DOCA department.

The assessment by the Ontario First Nations Technical Services Corporation did not take place due to the COVID 19 outbreak in 2020.

It has been almost two years since the COVID 19 restrictions have been lifted and our Nation has not contacted OFNTSC to assess the buildings at 4065 Hwy 6.

It is possible MCFN could renovate the buildings in question, to provide storage space, office space for MCFN or office space rentals.

The question is who does the Direction go to in order to have the first question answered; are the buildings stable enough to spend dollars to renovate?

Councillor EF's suggestion, at this time, is to provide the A/SED Director to reach out to OFNTSC to arrange for one of their employees to assess the buildings at 4065 Hwy 6 that are located behind the DOCA Department.

### **DIRECTION NO. 2**

That the Mississaugas of the Credit First Nation (MCFN) Intergovernmental Relations Council directs the Interim Executive Director of Operations to follow up with contacting someone at (OFNTSC) Ontario First Nations Technical Services Corporation to assess the buildings belonging to MCFN that are located at 4065 Hwy 6 behind the DOCA (Department of Consultation and Accommodation).

Councillor EF suggested that we get our Treaty Maps made into puzzles for our LSK students.
