AGENDA ITEM NO. 5 - FORMER EKWAAMJIGENANG CHILDREN'S CENTRE (LM)

Councillor LM noted in her Briefing Note that she is requesting to use the space of the former Ekwaamjigenang Children's Centre (ECC) for the summer camp sessions.

The ECC building remains empty and needs a few renovations to allow the Community Support Program to operate the Summer Day Camps at this location. It could also be used to house the Community Support Department permanently, along with other programs.

To my knowledge there are a few toilets that would need to be changed to regular toilets and perhaps a couple of sinks raised for the interim. As to date, the Community Support Program has been resilient in making spaces work for their programs. I have talked to Yvonne regarding this recommendation and she agreed that the space would be ideal for camp.

If approved, perhaps Employment and Training could fund a cleaner to do a deep clean of the rooms and washrooms at the end of each day.

Dollars will come from the Community Wellness Jurisdictional Initiative Fund (CWJI).

AGENDA ITEM NO. 7 – PRESENTATION BY DIANE LONGBOAT REGARDING LAND ACKNOWLEDGEMENT AND CAMH (LM)

Councillor LM noted in her Briefing Note that Diane Longboat would like to discuss co-creating a marker/indoor art/outdoor to honour the land where CAMH sits today. We know from the Colonial Records that MCFN used the land as Council Grounds.

The following is a letter/request from Diane Longboat to Councillor LM:

I am writing today to ask for your guidance from CAMH-Centre for Addiction and Mental Health, Shkaabe Makwa Centre for First Nations, Inuit and Metis Wellness. CAMH is the largest hospital in Canada for these challenges and an international centre for research. Shkaabe Makwa is concerned with the

development of culturally appropriate clinical services for our people, research, strategic initiatives, and wellness innovation.

Some years ago, then CEO Catherine Zahn, and I developed the land acknowledgement. We understood from our research that the site of the hospital on Queen Street West in Toronto stands on the Council Grounds of the Mississaugas of the Credit. Trade, commerce, governance, treaty making were all conducted in this region. I asked Stacey LaForme to check over our writing and he took it to Council for their input. They liked it and approved. Now I am reaching out to share news that new buildings are going up on this campus area and we want to mark the land with recognition of its importance to MCFN and CAMH.

We are convening a committee for discussion on how we might proceed. To date, we have Jay Havens from Six Nations working on outdoor water art and Michael Belmore working on rock (erratics) carving also an outdoor art piece. We would like to invite you or a representative from MCFN to sit with us to guide the discussion on what might best represent the presence of MCFN and honour the Council Grounds.

I am at Six Nations and happy to drop over for a conversation. Thanks so much!

Ms. Longboat reiterated that she would like Council to review the attached Land Acknowledgement, and the development of a marker from MCFN. At the present time, she is just gathering information. She added that there are two new buildings being built on the CAMH property – a new forensics building and another new building connected to the Justice System.

Ogimaa-Kwe stated that we need some kind of plaque recognizing MCFN as the Treaty Holders.

Ms. Longboat noted that what Hagersville and Hamilton need is a clinic. She also questioned if someone from MCFN Council would create a committee who would be willing to work on the marker.

Ms. Longboat was thanked for her presentation and left at 9:50 am.

Councillor LS questioned how this item got on the Agenda. Councillor LM answered that it was through her Dad. Councillor LS then questioned if we are an afterthought. What about the Metis – do they have a part in this? Councillor EF answered that the Metis did not have land in Ontario. Ogimaa-Kwe added that COO said that only the Red River Metis were legitimate.

MCFN has a Pride flag from videos filmed in previous years that is able to be raised upon Chief and Council approval, the Communications and Engagement Lead has also drafted an accompanying statement.

AGENDA ITEM NO. 13 – PRESENTATION VIA ZOOM BY PEACE HILLS TRUST (GEORGINA VILLENEUVE & JEFF FRKETICH) REGARDING TORONTO PURCHASE TRUST INTERIM REPORT & Q1 2024 PERFORMANCE REPORT

Georgina highlighted the Interim Report. She stated that 2/3 of the Trust is now taxable because of new rules. This will slow down the growth of the Trust.

Jeff introduced two new people - Ryan Bruce and Brian Maddox who are working at Peace Hills Trust.

Jeff informed that Mawer is not doing good. Mawer should be getting better returns, and Jeff may change this.

Fiera does does not look good at present, but they are coming back.

Jeff is always stressing that MCFN needs to focus on the long term. He noted the following in his report:

The story for the markets since the pandemic has been centered on inflation and interest rates. Interest rates were increased dramatically to counter high levels of inflation that had not been seen for decades. The economy slowed, and people feared that we could face a recession. The good thing is that the strategy worked: higher interest rates succeeded in bringing inflation down to a manageable level. It peaked in June 2022 but is now down to around 2.8%.

The question now is when will the Bank of Canada (BoC) and the Federal Reserve in the US (Fed) start to lower interest rates? Most economists thought that rates would have started to decline by this time, but BoC and the Feds have remained firm that there is still some work to be done before rates can come down.

Peace Hills works with several of the top independent investment managers across the country. Generally, they were not in agreement with the consensus view that rates would come down in the short term. In the fall of 2023, most of these managers felt that interest rates would stay 'higher for longer', and this is exactly how it has played out. Some of them now are of the opinion that higher rates will be here for a while. We must remember that historically, interest rates hover around 4% and that the ultra-low rates we had during the pandemic were a temporary measure.

Higher rates have both positive and negative effects on your Trust portfolio. Higher interest rates mean that any bonds you buy now will pay a much higher rate of interest than bonds did a few years ago. On the other hand, higher interest rates usually mean poor stock market performance because the economy slows down.

Fortunately, the 'soft landing' that people were hoping for seems to have occurred. High interest rates helped to lower inflation without causing the economy to stall. The markets took this as a good sign, as can be seen in the 2024 first quarter results: Canada was up 6.6%, the US was up 13% while the international market finished 8% higher. The only asset class to do poorly was bonds, down 1.2% for the quarter.

The simple fact is that no one can accurately predict when interest rates will begin to decline. Your managers don't worry about the market 'noise' that investors are constantly bombarded with. They focus on a long-term approach: purchase good companies and hold them for a long time, which allows the companies to grow, resulting in an increase in their stock price. This is a perfect fit for your Trust, because its long-term time perspective fits perfectly with the way your managers build wealth. It is a simple approach that works.

Councillor VKJ questioned what can be done, if anything, regarding paying higher taxes. Georgina answered that she is lobbying with a couple of firms, but she will get back to MCFN once she does more investigating.
