**AGENDA ITEM NO. 5 – SENIOR DIRECTOR OF FINANCE (SERGEY HOVASAPYAN) WILL BE INTRODUCED TO OGIMAA-KWE & COUNCIL**

Ogimaa-Kwe introduced Sergey Hovasapyan to Council. He is the new Senior Director of Finance, and started work yesterday (Monday, June 24, 2024).

**AGENDA ITEM NO. 6 – WASTEWATER COMPLETION PLAN – ISC REQUESTED – MINOR CAPITAL APPLICATION (AL & WS) (BCR TO BE SIGNED IF APPROVED)**

Councillor LS informed that he requested the PW Director to put this Plan together.

PW Director noted in his Briefing Note that a Motion of Council is requested to approve the Wastewater Completion Plan prepared by Public Works Department (PWD) to be included in a Minor Capital Application (MCA) and submitted into Indigenous Services Canada (ISC). In addition, authorize the signing of a Band Council Resolution (BCR) be included in this submission.

Former Councillor Ashley Sault and Director of Public Works met with Indigenous Services Canada (ISC) officials in late December 2023. ISC requested a Wastewater Completion Plan and associated budget amounts for planning purposes.

Former Councillor and PWD recommended we proceed in a similar fashion as the Water Agreement established between MCFN and SNGR to adequately service MCFN/SNGR First Nation members.

Former Councillor and PWD met with SNGR (Michael Montour) to confirm collaboration and participation in this Wastewater Completion Plan as a joint venture like the Water Agreement previously completed.

First Nations Engineering Service Ltd. (FNESL) have expressed concern that the current lagoon will not adequately accommodate the additional wastewater needs of MCFN given the development and future development.

Further investigation needs to take place to confirm whether the lagoon system can accommodate future development.

Future expansion with the possible construction of a new lagoon will need to be determined.

PWD received a Class "D" budget from First Nations Engineering Service Ltd. (FNESL - attached).

Interim Executive Director of Operations, Councillor Larry Sault, PWD and Infrastructure Manager (Brandon Hill) met with ISC to discuss the next steps to move this project forward. As outlined a feasibility study will be completed as first stage of the project described by the MCA (Minor Capital Application).
