**AGENDA ITEM NO. 5 – PRESENTATION OF MONTHLY OPP REPORTS FOR APRIL AND MAY 2024**

Jodi Kays OPP Inspector went through the OPP Monthly Reports for May and June 2024. She stated that their detachment (Cayuga) has some brand new recruits.

Ogimaa-Kwe informed that homeless people are camping next to T. Herkimer's. Ogimaa-Kwe will check with the home owners and see if permission has been granted for these people to be on their property. Jeff (OPP Officer) added that the Lawson House in Hagersville is now closed and the people who were living there are wandering around the area.

There was a disturbance around T. Herkimer's property, and the OPP were called. Jeff will follow up.

Jodi pointed out that when these people are picked up by the OPP, there is nowhere to take them.

**AGENDA ITEM NO. 6 – BAND TRANSFER POLICY – ADULT AND MINOR (LM DIRECTOR)**

LM Director provided an update as to what is happening with the Adult and Minor Transfer Policy.

Councillor LS stated that we should do our own Membership Code and not let ISC decide who should be on our List. He also stated that we have serious issues with identity fraud.

There was a suggestion that the LM Director strike a Committee, and Councillor VKJ added that we would need a Knowledge Keeper on this Committee. She also suggested that we put this policy together with the MRP.

**DIRECTION NO. 1**

That the Mississaugas of the Credit First Nation (MCFN) Intergovernmental Relations Council directs the LM Director to set up a meeting within a month (Tuesday, June 9, 2024 – Intergovernmental Relations Council Meeting, for one hour) regarding the Band Transfer Policy and Membership List.

**AGENDA ITEM NO. 7 – SIX (6) WEEK WAIT FOR LOST/STOLEN CERTIFICATE OF INDIAN STATUS CARDS (LM DIRECTOR)**

LM Director brought this item to Council as MCFN Members are complaining that six weeks is too long to wait for a renewed status card when it has been lost.

An MCFN Member has raised concerns with Chief and Council regarding the current policy that mandates a six-week waiting period for the replacement of lost or stolen status cards. This waiting period has been identified as a significant inconvenience, impacting the Member's ability to access essential services and benefits tied to their status card. The member has requested that Chief and Council review and potentially revise this policy to expedite the process and alleviate the challenges faced by Community Members during this waiting period.

Given the change in circumstances, with no longer a shortage of Status Cards from ISC, and a reduced volume of reported lost or stolen cards, the LM Department is now able to amend the process and revisit the six-week waiting period.

Though we are able to amend the waiting period, the LM Department will still have to follow ISC rules in the Indian Registration Administrators Training Manual states that

*"A registered individual may possess only one (1) CIS at any given time. For fraud prevention, a maximum of two (2) CIS' shall be issued to the same individual within a 12 month period."*

That the Mississaugas of the Credit First Nation (MCFN) Intergovernmental Relations Council agrees to modify Motion #11 from the Land, Water & Sustainable Prosperity Council meeting from November 15, 2022. From a mandatory 6-week waiting period for all lost or stolen Certificates of Indian Status cards to a 3-week waiting period for all lost CIS cards and no waiting period for all stolen CIS cards with a valid police report. This new rule will apply to both Secure Certificates of Indian Status cards and Certificate of Indian Status cards.
