AGENDA ITEM NO. 5 – FIRST NATIONS INFRASTRUCTURE INVESTMENT PLAN (FNIIP) (PW DIRECTOR) (BCR TO BE SIGNED IF APPROVED)

PW Director noted that a Motion and BCR are required to fulfill the reporting requirements of Reports Ontario and Indigenous Services Canada (ISC) with respect to the First Nations Infrastructure Investment Plan (FNIIP) Submission for 2024/2025 fiscal year.

In the past, MCFN has fulfilled the reporting requirements with planning in mind for the next ten (10) years where Housing and Asset Condition Reporting System (ACRS) Housing and Health and Safety issues are addressed.

As Director of Public Works, the responsibility of the department is to ensure succession planning and future development needs from an Infrastructure perspective are being met and that ISC is cognizant of future development within our First Nation Territory so that we do not jeopardize nor are excluded from the potential funding opportunities that may be available for MCFN.

AGENDA ITEM NO. 6 – PM WORKSHOP CONTINUATION (AS) (THIS ITEM IS COMING BACK FROM LAST WEEK'S MEETING)

Councillor AS noted that Pillar 6 Lead is interested in a leadership/project training course, along with employees under Pillar 6.

The first part of this training was done by Pillar 6 Lead (and PW Director) last term, however, this part of the course will be more in-depth for a better understanding. Along with three other employees under Pillar 6 who are interested, Pillar 6 Lead will complete the training, if approved.

The Council requested the Verification Form be brought forward to establish that the Pillar's budget can be utilized for this. Senior Director of Finance provided the Verification Forms for all four participant's amounts.

That the Mississaugas of the Credit First Nation (MCFN) Infrastructure & Environmental Stewardship Council agrees to allow Pillar 6 Lead, Councillor Ashley Sault, to register for the Case-Based Training Workshop through Environmental Project Management & Sustainability Solutions, in the amount of up to \$5,000.00 (FIVE THOUSAND DOLLARS) – Registration amount may be less if other employees are able to register. Dollars to come from Pillar 6 Budget – according to attached verification form.

And further, that the Mississaugas of the Credit First Nation (MCFN) Infrastructure & Environmental Stewardship Council agrees to allow Pillar 6 Lead Councillor Ashley Sault, Director of Public Works, and 2 Employees from Housing to register for the Case-Based Training Workshop through Environmental Project Management & Sustainability Solutions in the amount of \$18,800.00 (Eighteen Thousand Eight Hundred Dollars) total. Dollars to come from the Pillar 6 Budget in the interim until budgets are approved and, if available, the individual costs will be GL'd back to the relevant departments – process recommended by Finance Lead.

In addition to the above, Councillor Fawn Sault will be registered to take the training at a further cost of \$4,700.00 (Four Thousand Seven Hundred Dollars) for a total of \$23,500.00 (Twenty-Three Thousand Five Hundred Dollars).

AGENDA ITEM NO. 7b) - WILLOW PROJECT COMMITTEE - DONATION REQUEST (AS)

Councillor AS noted the Willow Project Committee (WPC) needs their budget approved for a portion of the Feasibility Study to be completed as well as engagement to be done.

It is my understanding that former Councillor Bill Laforme brought forward the WPC's established budget earlier this year in order for the Committee to push forward with the Feasibility Study portion of the Next Steps. A big part of this budget includes the cost of engagement with the Community for input.

The budgets have not been approved yet, and the Willow Project has stalled, and a big part of the Feasibility Study is engagement.

The WPC is looking to push through with engagement which includes a survey out to our Youth right now. It has not gotten great attention, so we are going to offer a gift card draw as an incentive for our Youth. We are also going to set up a table at all three days of Caring Together Week (CTW) and have separate youth/adult surveys available and once they complete it – they can enter their name in a draw that will be drawn at the end of CTW. These are two separate draws.

Right now, without budgets approved – the committee cannot use the budgeted dollars to get these gift cards so we, as the committee members, have put together our own monies and have been able to come up with \$250 towards these two draws. The plan is to split them between both draws right now. We are coming to ask Council if – in the event our budgets remain unapproved – this table will donate \$1,000.00 to the Willow Project Committee for us to complete some engagement in the coming weeks. It will not cover all the engagement process, but it will make the draws better.

Mike Schreiner, MPP for Guelph and Candace LePage in at 10:40 am.

AGENDA ITEM NO. 7d) - PRESENTATION BY MIKE SCHREINER - GREEN PARTY LEADER & MPP (CS) (REQUIRES ONE HOUR)

Ogimaa-Kwe introduced Mike Schreiner to everyone around the Council Table. Mike is part of the Green Party. He came here today to meet Council, and to talk about the proposed park in Guelph. The buildings used to be a correctional facility, and there are murals that were painted by Indigenous inmates, and the murals need to be preserved.

There are issues in Guelph regarding Treaty Holders.

Mike stated that he has not endorsed the lands yet as Guelph is looking to build a new hospital, and he wants to wait until the hospital is finalized. Guelph is not engaged in where to build the hospital yet. Mike stated it was important for him to tell MCFN right up front as MCFN is the Treaty Holder.

The property is 350 acres and sits on a flood plane. Only 49 acres are not sitting on the flood plane.

Ogimaa-Kwe stated that our challenge is Indigenous people popping up everywhere that are not really Indigenous.

Mike would have to come up with the criteria of who he would be endorsing. He also stated that he will be asking Guelph Council to consult with MCFN as there are a lot of competing groups. Ogimaa-Kwe stated that she would be happy to help.

Step 1 will be no paving over green space. Step 2 is making sure our infrastructure is climate ready. He further stated that he would like to work with MCFN regarding climate change and renewable energy. Step 3 would be learning how to electrify heat pumps.

Ogimaa-Kwe stated that MCFN would like to be an asset to Mike and the Green Party.

Mike Schreiner, MPP for Guelph and Candace LePage were thanked for their presentations and left at 11:15 am.

Council moved back to Agenda Item No. 7c).

AGENDA ITEM NO. 7c) – AIAI DATA GOVERNANCE GATHERING – NOVEMBER 26 – 27, 2024 (CS)

Ogimaa-Kwe informed that there is an AIAI Data Governance Gathering that is scheduled for November 26-27, 2024.

The Association of Iroquois and Allied Indians (AIAI) is hosting an in-person 1.5 Day Data Governance Gathering to take place on **Tuesday**, **November 26**, **2024 – Wednesday**, **November 27**, **2024 (Half Day)**. The purpose of this event is to begin dialogue about: OCAP, Data governance, asserting jurisdiction over data, development of community capacity to support data governance. This event would be beneficial for Chiefs, Councillors, Health/Social and Education Directors to attend.

Council moved to Agenda Item No. 7e).

AGENDA ITEM NO. 7e) - FALL HARVEST BUDGET APPROVAL (LM)

Councillors Ashley Sault and Leslie Maracle noted that the Fall Festival is historically organized and run by the Culture and Events Unit who are off on sick leave. It is imperative to move forward immediately as the Fall Festival is only one month away – October 18, 2024.

Councillor LM informed that she talked with her Dad (Mark Sault) who advised her to go ahead and plan the Fall Festival.

Councillor JH mentioned that there are a lot of proponents who would like to help. He can reach out to CLC. Councillor EF suggested sending a letter to the proponents.

Councillor AS noted that we need to send out a flyer as soon as possible.

Ogimaa-Kwe suggested putting together a list of events and costs.

As a side note, Councillor VKJ questioned if all the Pillar Leads had their work plans and budgets completed, but the answer was no.
