# AGENDA ITEM NO. 5 – 2024-2025 ONTARIO REGIONAL ALLOCATION FOR INDIGENOUS EARLY LEARNING AND CHILD CARE (IELCC) TRANSFORMATION INITIATIVE FUNDING – AMENDED AGREEMENT (PB)

Director of Lifelong Learning noted in her Briefing Note that she is seeking Council to approve the Indigenous Early Learning and Child Care (IELCC) Transformation Initiative First Nations Distinction Funding Agreement with Employment and Social Development Canada which includes amounts for First Nation Inuit Child Care Initiative (FNICCI) and Infrastructure Funding allocation for 2024-25.

MCFN has been in this agreement with Employment and Social Development Canada (ESDC) since April 1, 2020, this agreement ends March 31, 2026.

This amended agreement was received on Tuesday March 5, 2025. It helps fund the child care daily operations including wages and benefits and professional developments for improvements in the Early Years Programs.

# <u>AGENDA ITEM NO. 8 – HYDRO ONE SECOND METER AT INDUSTRIAL PARK (SED DIRECTOR)</u>

Amanda Braun (SED Director) noted in her Briefing Note that she is seeking approval for signatures from Hydro One to add a second meter to the Industrial Park so Lands and Membership have their own meter separate from Wingers and Six n One.

Since 2015 MCFN has had one hydro service meter for three tenants. DOCA (2015-2017), Lands and Membership (2018 – Present), Six n One Stone and Wingers Custom Cabinets. There has always been an allocation and expense recovery. I found an error in L & M square footage, and they were charged incorrectly. We have also been paying Six n One and Wingers hydro. Wingers has paid their portion of the bill, but Six n One has not because no lease has been signed. A separate meter installed will ensure that the Industrial Park tenants pay their own Hydro One accounts.

We currently have one meter installed forcing MCFN to pay the bill, do an expense recovery, and making twice as much work for the finance team.
