**AGENDA ITEM NO. 5 – PRESENTATION BY JEFFREY SMITH REGARDING THE NIAGARA REINFORCEMENT LINE (NRL) (EF)**

Jeffrey stated that this is an update of the Niagara Reinforcement Line. Councillors JH and EF are on the Advisory Committee.

The NRL goes from the Falls to Middleport.

Councillor AS questioned how the tariffs would affect us. Jeff answered that the tariffs will have very little impact on the return on equity (ROE). He further stated that we had an excellent year.

Councillor LS requested to see the numbers of what we are actually exporting. He also requested a bigger picture of our own regulatory laws – OEB. Jeff answered that he will get this information to MCFN.

Councillor VKJ suggested taking one of our Youth to see the NRL.

Jeff noted that there are two new lines: Chatham to Windsor which was recently completed, and Thorold to Welland is at capacity, but the line will need to be completed and we will be partnering with Indigenous partners.

**AGENDA ITEM NO. 6 – SENIORS & YOUTH – INVITATION TO BE ON THE AGENDA THE FIRST TUESDAY OF EACH MONTH**

MCFN Member Veronica Tobicoe stated that the Seniors in the Community are still feeling left out. She is suggesting that Chief and Council should just go and visit them (Seniors), and do not wait for the Seniors to call.

Councillor EF stated that she almost got her leg torn off by a dog when she was campaigning, so she will not go door to door anymore. She also noted that not many people in the Community want to hear from Chief and Council.

MCFN Member Veronica stated that we need to train our people to reach out to our Elders and to each other. She also stated that it is hard to access services here at MCFN. For example, some Seniors need incontinence supplies and they do not get them.

Ogimaa-Kwe noted that one of her solutions is to find dollars to hire someone to go and visit the Seniors.

Councillor VKJ informed that she has a list of Seniors.

Councillor As questioned if we could look at hiring a Senior's Advocate.

Council moved to Agenda Item No. 10.

**AGENDA ITEM NO. 10 – PRESENTATION FROM NATIVE HORIZONS TREATMENT CENTRE (NHTC) (LM)**

Councillor LM noted in her Briefing Note that Native Horizon's Treatment Centre would like MCFN Council's support to construct a gym at their site on New Credit Rd.

NHTC leases the land at 130 New Credit Rd. They have hired CSS Consulting Group to assist in acquiring funding and a plan for the gym. Wanda, Executive Director of NHTC has been in contact with Two Row Architect for the construction. Physical activity is important to a person's wellbeing.

Currently the newly constructed NHTC has had cohorts access the program and unfortunately they have no place for physical activity. They have tried to accommodate the clients by providing some weights. NHTC in the past has rented the LSK Gym. Since COVID and renovations the LSK gym has been unavailable. The community would be able to utilize the gym as well.

Wanda Smith and Ron Gersh are here today to present to Council where things stand.

They are requesting a BCR to be signed to support this development.

Wanda informed that once the gym is up and running, it will also be available to the Community. The land has already been surveyed.

Councillor JH stated that there are a lot of other things that need to be done, eg. documentation that needs to be completed.

Wanda Smith and Ron Gersh were thanked for their presentation and left at 11:20 am.

Council moved back to Agenda Item No. 7.

**AGENDA ITEM NO. 7 – NEW CREDIT CHURCH RECORDS (EF)**

Councillor EF noted in her Briefing Note that she was granted permission to obtain the Digitized United Church Records from the MCFN, Lands, Research and Membership Department, via a Council Direction.

The Lands Research and Membership Director employed Darin Wybenga to digitize the records from the New Credit United Church. The Church records contain information on Marriages, Births, Deaths and Christenings. The contract to complete the digitized records took several months.

When Councillor EF asked for the digitized records, she was informed the previous Director left without providing the new Director the password for the digitized records. The previous tech person was brought in to retrieve the password for the digitized records.

Since September 3, 2023, she has returned to the Council Table more than three times to request to obtain the digitized United Church Records and share them with the Delaware United Church. As at today's date the request for the New Credit United Church Records has not taken place.

Since 2024, I have been provided with various information in regard to our digitized Records:

1. The Administration Clerk could access this information from her computer.
2. The A/CAO in 2024 did not renew the license to retrieve our digitized Records.
3. The CAO in 2024, stated at the Council Table that she did not renew the license to obtain the digitized Records, as she has purchased a better records system.

**AGENDA ITEM NO. 8 – GARY MIEDEMA/CITY OF TORONTO – TORONTO HISTORICAL SIGHTS (EF)**

Councillor EF noted in her Briefing Note that Gary Miedema requested a letter of support from the MCFN to be sent to the Native Canadian Centre in Toronto.

The letter was to state the MCFN supports the work that Gary Miedema is engaged in to interview Indigenous Organizations, Inuit and Metis in Toronto. Mr. Miedema is putting together a list of specific areas in Toronto that have special meaning for the Indigenous organizations, the Metis and the Inuit.

The MCFN Council requested the Inuit and Metis be removed from the letter before signing off.

The Native Canadian Centre Board would not participate in the project until the MCFN provided a letter of support for the research being conducted by Gary Miedema/City of Toronto.

Councillor LS noted that there is no mention of the Metis. Councillor EF answered that it was removed from the letter (the mention of Metis). He also suggested that we should add “We do not recognize the Metis in our Traditional Territory”.

**DIRECTION NO. 5**

That the Mississaugas of the Credit First Nation (MCFN) Financial Planning & Fiscal Oversight Council directs Councillor Erma Ferrel to contact Arlene Dodge at the Native Canadian Centre in Toronto regarding the letter that was sent to her from MCFN dated February 19, 2025. An addition could be made to the letter to further clarify that we are of the opinion that we do not support the Metis.

**AGENDA ITEM NO. 9 – ARTWORK AND RECOGNITION AT CAMH (CANADIAN ASSOCIATION OF MENTAL HEALTH) (LM)**

Councillor LM noted in her Briefing Note that after meeting with Diane Longboat at CAMH in Toronto we have come up with a few suggestions for the recognition of MCFN at CAMH.

In a previous Council Meeting, Diane presented to us that CAMH would like to recognize MCFN lands with some artwork of some sort on their property. They would like this artwork to be representative of MCFN. This is why she has reached out to us.

While touring the site, it was suggested to implement a 4 directions garden, 7 iron sculptures to represent our 7 grandfather teaching animals and a commemorative marker.

Once approved we will move forward on sourcing an artist and funding. Diane will also need to reach out to the Redevelopment Team once Chief and Council agree. Diane has reached out to the City of Toronto and has been told that MCFN will be meeting with the City of Toronto soon.

This is an FYI for Chief and Council, however, Councillors Fawn Sault and Leslie Maracle will follow up.

**AGENDA ITEM NO. 12 – EARLY YEARS REQUEST TO PURCHASE OVER SIGNING LIMIT (EARLY YEARS ADMINISTRATOR)**

Early Years Administrator (Katharine Brown) noted in her Briefing Note that she is seeking approval for a purchase over the signing authority of the Early Years Administrator and the signing of the contract by the A/Chief Administrative Officer. Any purchase over \$5,000.00 has to be approved by Council.

The fencing supplier “Jay’s Fencing” is a preferred vendor for MCFN community projects with proven high-quality materials, workmanship and competitive pricing evidenced by other projects completed within the territory and overseen by the Public Works Department. The cost of the fence is \$19,300.00 (nineteen thousand and three hundred dollars and zero cents). The fencing will be installed in the forest area located adjacent to ECC for the purpose of creating and maintaining a “Forest Playground” for children aged 0-6years. The funds for this purchase will come from ‘Indigenous Early Learning and Child Care – Infrastructure’. (600740).

Councillor LS stated that we should issue three bids. If we do not do this we violate our own policies. MCBC has a relationship with a fencing company, and why not use them? Director of Lifelong Learning answered that she obtained the name from the PW Director.

Georgina highlighted the Financial Statements as prepared by MNP Auditors. She highlighted Management’s Responsibility and the Independent Auditor’s Report. The Audit is 100% correct.

Councillor LS questioned how the US tariffs would affect us. Jeff answered that things will be difficult right now, but this is only temporary. He reiterated that the Trust is going to be around for a long time, and we will have to ride this out for the next three or four years, but the Trust is ok.

**Fourth Quarter 2024 Market Update**

The fourth quarter of 2024 started with caution rather than confidence, as investors hesitated due to uncertainty surrounding the U.S. presidential election. This uncertainty slowed Canadian market growth in October, with the S&P/TSX rising just 0.65%. Technology stocks led the gains, while interest rate-sensitive sectors like real estate and utilities declined.



In November, Canadian stocks surged 6.2% following Donald Trump's election victory. Investors believed his "Make America Great Again" agenda would positively impact Canada due to the close economic ties between the two countries. Market optimism grew as inflation dropped below 2%, leading to expectations of further interest rate cuts from the Bank of Canada. Shortly after the S&P/TSX reached a record high, the Bank of Canada made its fifth consecutive rate cut, lowering the policy rate by ½ of 1% to 3.25%. This move aimed to stimulate economic growth amid a slowing labor market.

### **Bond Markets and Interest Rates**

Canadian bond markets remained stable in October, supported by steady inflation and investor confidence. However, in November, bond yields rose on optimism following the U.S. election. The market turned volatile in December after Canada's finance minister resigned, causing fluctuations in bond yields.

Councillor EF questioned what is happening with Mawer. Jeff answered that Mawer is underweight which means they are losing a lot of clients, and those clients are moving to Dixon Mitchell. Jeff suggested moving away from Mawer as MCFN is well diversified. Georgina added that we can bring in other Managers if that is what MCFN wants.

Councillor LS questioned where the dollars are that we are paying to HONI (see Page 7 of Financial Statements)) Does the \$10 Million ever get paid off. Georgina answered no. This is an asset that never gets paid off.

This is a request to travel to London, England from May 2-8, 2025 for O'gimaa Kwe Claire Sault, Councillors Veronica King-Jamieson and Erma Ferrell.

Building on the success of the 2023 Mississauga Delegation to the United Kingdom and Isle of Man, the following itinerary has been prepared for the Ogimaa Kwe for a proposed delegation to London from May 2nd-8th, 2025. This delegation will continue to work through The King's Anishinaabek Sacred Place to strengthen relationships with friends in the United Kingdom, as well as reinforce the Silver Covenant Chain with His Majesty the King. This delegation's visit comes at a time when the Crown in Canada, including its Treaty Relationships, is facing an existential threat from the Trump Administration.

Councillor AS questioned how travelling to England is going to help the First Nation, and why are we paying money to go and shake the King's hand? Councillor EF answered that we are looking at it as relationship building through Massey College. Further, we will likely pay our own way.

Councillor LM questioned how people got picked to go. Councillor EF answered that an email was received from Nathan Tidridge inviting us.

Councillor LS suggested going through Nathan and Cannon Wright to get an audience with King Charles.

Councillor EF will now book the flights.
