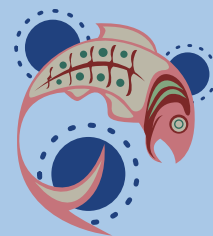

So happy to be embarking upon spring.

I'm so thrilled that we were able to get our Rouge River Valley Claim to a final agreement. The senior government staff conveyed that this is the fastest progress they've ever seen. More importantly now, is to ratify the claim with you as members and go through it in more detail and answer your questions so you can make an informed decision.



My apologies that I couldn't be with you at the Community Meeting on March 29th. I was with Mayor Horwath working to bring the Junos to Hamilton in 2026.

We are close to finalizing the framework for our Youth Council. Thanks to Councillor Veronica for her assistance. She has been meeting with the Youth and provided several training sessions. Our hope is that they'll be able to start their own election process by the fall. This Youth Council is important for us to capture the voice of our young people and to have them better prepared in the long-term future of an elected Council seat when they become adults.

We continue the work of sourcing funds for a number of initiatives. Councillor Leslie has been appointed to pursue the Four Pillars Society funding. My hope is to use the funds to start the preliminary steps for the cultural centre. This initiative has been discussed and has had community engagement on what we commonly known as the Willow Park property that the Nation purchased a number of years ago. The committee will reconvene so stay tuned for progress updates on this major undertaking.

On the larger claim, Treaty 22 & 23, we have worked diligently to progress this claim forward. With the federal election being announced, we will continue to keep it on the federal government's agenda and radar. Much progress was made on that claim but of course we knew we might be faced with the federal election coming right toward us and impeding our ability to continue. We certainly did as much as we possibly could and are currently in pause mode. For now, we have to wait until the election results (April 28) and the new government gets settled in before we can continue.

The Council has engaged planners (Urban Strategies) to help us establish our priority list of projects. We will be seeking a project manager to drive this work forward. We have so many competing priorities such as developing infrastructure (water & wastewater lines, upgrading lagoons, developing the lands below the train tracks), wellness, United church, and external opportunities to invest. Some of these projects have been on hold for a number of years so I'm confident we'll be under way with starting shortly. We do have to determine how we prioritize them.

Mississaugas of the Credit First Nation Rouge River Valley Tract (RRVT) Claim



March 12, 2025

Dear Mississaugas of the Credit First Nation Members,

We are happy to announce that Canada and Ontario have made us an offer to settle our land claim - the Rouge River Valley Tract Claim.

Background

We first started the claim back in June 2015. The RRVT Claim is based on the fact that the RRVT forms part of the Territory of the direct ancestors of the MCFN. The RRVT has never been lawfully surrendered by MCFN or its ancestors. As such, we assert that we maintain unextinguished Aboriginal Title to the RRVT. The RRVT does not form part of any other valid Treaty nor land surrender entered into by the MCFN.

The RRVT does fall within the boundaries of the 1923 Williams Treaties. However, the MCFN is not a signatory to those Treaties. We in fact still have an outstanding action against Ontario under the Williams Treaties Litigation.

From 2024, all 3 parties have sat down and have been working on getting an agreement.

Current Development

On Friday March 7th, 2025, the parties initialed the final settlement agreement.

The Mississaugas of the Credit Chief and Council are recommending that this settlement offer be accepted and each member over the age of eighteen is asked to vote online from March 12th, 2025 at 9:00 a.m. until April 12th, 2025 at 8:00 p.m.

Voting instructions are included on the next page.

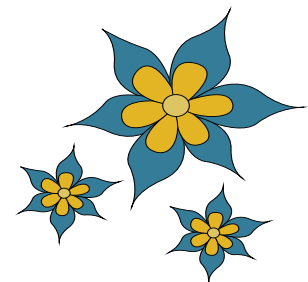

February 28, 2025

The Sheridan College Indigenous Engagement & Education office hosted their official opening. Eddy Robinson, our current A/CAO, provided an opening prayer and drum song. The staff of the Sheridan College Indigenous Engagement & Education office wish to work with MCFN on an Memorandum of Understanding agreement.

Museum Exhibit

The Brampton Museum has been working on a new Exhibit with the focus on First Nations Peoples. The facilitator of the committee has been hosting quarterly meeting via Zoom or in Person during the past few months. The previous display was removed in 2023, and a working committee have been providing input on updating the Exhibit at the Brampton Museum. I have participated in the quarterly meetings either in person or via zoom. The proposed new exhibit is scheduled to be completed in 2026. During the summer of 2025, a Canoe will be constructed on the ground of the Brampton Museum, to be placed on display in the Museum. Other portions of the Exhibit will include First Nation languages and traditions.

March 13, 2025

On March 13th, I hosted a Cultural working group with Members from, Halton Hills, Caledon, Burlington, and Oakville. The working group meets quarterly to share what activities they are hosting in their Municipalities. The majority of the working group attended our re-opening of our Council House in October 2024.

March 21, 2025

During the morning of March 21st, Councillor Jesse Herkimer and I met with the Niagara Reinforcement Line (NRL) working committee in Woodstock. The MCFN has a 20% investment in the NRL, which began in 2019. Annual revenue from the NRL, is approximately One Million dollars that is sent to the Toronto Purchase Trust, to grow the Trust. The interest earned on the Toronto Purchase Trust is paid to the MCFN annually. Upon receipt of the interest, the funding is distributed to the Members of the MCFN in the form of a Wellness Payment.

March 21, 2025

In the afternoon of March 21st, I participated in the Credit Valley Conservation working group zoom meeting. The working group met in person in the fall of 2024, to view the proposed site in Caledon along the Credit River, to place a marker. The marker will be a "Fish Doodem", to represent the Treaty and Traditional Lands of the Mississaugas of the Credit First Nation. In the fall of 2024, the first marker was officially unveiled at Island Lake in Orangeville. The marker was the "Crane Doodem. The Credit Valley Conservation working group will be completing 7 markers along the Credit River and representatives from the MCFN will continue to provide input on the designs.

February 13, 2025 - Red Jar Energy Partners (RJEP) is pleased to announce the signing of a multi-year Cooperation Agreement (the "Partnership") with the Mississaugas of the Credit Business Corporation (MCBC) to develop power and energy Projects within the traditional treaty lands of the Mississaugas of the Credit First Nation (MCFN).

This unique partnership combines RJEP's deep expertise in power and energy project development, corporate and project finance, and deal structuring with MCBC's ability to accelerate regulatory and permitting processes and attract low-cost project capital, while honouring and respecting the traditional treaty lands of the MCFN. RJEP and MCBC will focus on developing Projects at scale for the benefit of all Ontarians, while delivering on economic reconciliation for the people of the MCFN through the realization of long term and predictable cash flows.

The Partnership will target both large-scale generation and customer demand opportunities, such as data centres and major industrial manufacturing operations. Once a specific opportunity is identified and qualified, RJEP and MCFN will exclusively partner to deliver Impactful Energy Infrastructure. The first Project being developed under the Partnership is the Niagara Power Corridor, a critical transmission line designed to power the new Asahi Kasei Battery Separator Plant in Port Colborne and support the broader growing electricity needs of the South Niagara Region.

"We are deeply honoured to be partnering with MCFN, particularly given the size and significance of their traditional treaty lands", said Jason Sparaga, Managing Operating

Partner at Red Jar Energy Partners. "By working together, we aim to deliver timely energy projects that address the rapidly growing power demands in the province, while respecting the heritage, priorities and values of the MCFN community".

Ongoing Political Discussions Regarding First Nations Rights and the Métis Nation of Ontario

Greetings Community Members:

This notice is regarding an important and ongoing conflict between First Nations and the so-called Métis Nation of Ontario (MNO) which has been making headlines and sparking conversation across our region for the last few years.

As you may know, Leadership across our region, through the Ontario Chiefs-in-Assembly, are standing in solidarity against the MNO – a corporation without any s. 35 rights that is claiming lands and resources that belong to First Nations across Ontario. The MNO corporation is actively working to undermine First Nations rights in many ways. Our fight is not against individuals or against legitimate Métis peoples. This is an issue against a corporation that is trying to steal our identities, and in turn, our Ancestral and Treaty territories, by claiming to be something it is not and trying to rewrite both our histories and those of actual Métis peoples.

Actual Métis people originated in the Prairies as a result of mixed-race people living in separate communities and intermarrying with each other over many generations prior to the Crown asserting control of an area, and developing their own distinct culture, language, and systems for self-government. In contrast, the MNO is a corporation that was only formed in the 1990s to represent Prairie Métis that moved to Ontario (outside their homeland). Today, there is much evidence that the MNO recognizes non-Indigenous people as Métis and wrongly claims First Nations' Ancestors as "Métis".

Actual Métis scholars have noted in a recent report that "simply living in a place does not make a Métis community...there is a critical difference between being in a place and being Indigenous from a place."

While we work together as a region to combat yet another attack against our First Nation identity, we encourage all our citizens to stay informed, ask questions, and engage in respectful conversations. Chief and Council are available to provide further information and to address any concerns you may have.

Together, we remain committed to protecting our inherent and Treaty rights.

Message From The MCFN Trust Company Regarding Impact Of Trump's Tariffs

RE: Tariffs and Trust Valuation

US President Trump started a trade war with Canada on March 4, 2025, by imposing large tariffs on Canadian goods. Tariffs will increase the costs consumers pay for many goods and services. This will hurt Canadians but will also have a devastating effect on Americans. As with many things, Trump and his Republican cronies have either not thought this all the way through or simply do not care about their people, including their own. Some people will lose their jobs, and inflation will spike back up in Canada and the US.

The important question is: what effect will this have on the MCFN portfolio? The answer is complicated. The Canadian and US stock markets have lost approximately 8.6% since the tariffs were implemented. This sounds worse than it is.

First, let's think about **unrealized capital losses**. Recall the crucial point that the portfolio will not lose any money until an actual sale takes place. Also, a drop (or gain) in a stock's value does not affect the dividends that it pays.

Let's use TD Bank shares for our example. Let's assume the Trust buys them at \$80. TD shares pay a dividend of 5% every year, which works out to $(\$80 \times 5\% =) \4 per share per year. If the share price drops to \$80 to \$60, that is an **unrealized** loss of $(\$80 - \$60 =) \$20$ dollars. It is unrealized because the Trust has not sold the shares. This is commonly called a 'paper loss'. If, on the other hand, the Trust did sell at \$60, it would be a **realized loss** of \$20. The Trust would lose that \$20, it would be gone forever.

Now let's assume that for the next four years (the rest of Trump's term) TD stays at \$60. The unrealized loss of \$20 would still be there. However, the TD shares would have paid the Trust (4 years X \$4 =) \$16 in dividends over that four-year period. That is real money to be spent or reinvested.

Now let's assume that in four years time TD shares go up to \$90. What does this mean for the Trust? If the Investment Manager thought that the shares would not go any higher, they would sell shares at \$90, the gain would be realized, and the Trust would make a real profit of \$10. That \$10 could be paid out to the Nation or reinvested.

The major point here is that by not selling at \$60 the **Trust did not lose any real money**, it was a paper loss only. And while holding the shares until they rose in value, the Trust made \$16 real dollars in dividends. Those dollars could be paid out to the Nation or reinvested.

So, what does this all mean in real dollars? The Trust bought the shares at \$80, held them for four years. The shares went to \$90 and the Investment Manager didn't think the shares would go any higher, so they sold them. The Trust would make \$10 from the sale plus the \$16 in dividends that it was paid over the four-year period, for a total real dollar cash flow to the Trust of (\$10 + \$16 =) \$26.

This is a hypothetical case, but a very real scenario. In Covid, the stock markets went down over 30%, 10 times more than what has happened in the last few days. How much money did our First Nation clients lose?

None.

Yes, there were unrealized capital losses (paper losses) for a while, but the Investment Managers did not sell any shares (so no real money was lost), the market came back, and the portfolios showed gains and sold shares at a profit.

The ironic thing, and something that people sometimes find hard to understand, is that when the markets go down significantly, Investment Managers are not selling stocks, they are **buying them**. This is because when the market goes down, some very good companies go 'on sale'. The Investment Managers buy them knowing that, over time, the companies will make money, and their shares will increase in value. As well, most of the companies in your Trust pay dividends every year, so the Trust gets paid while it waits for the market rebound.

The keys to investing are this:

- Hire good Investment Managers that have solid 10-year track records (your Trust has some of the best in Canada)
- Buy good, established companies that will grow and make money year after year (these are the types of companies that pay dividends every year and are the type your Trust owns)

- Hold those companies for a long time, so that as they grow their earnings, the share price will increase

I have said it many times, the Nation has one great advantage over any individual: it will be around for a very long time, forever in fact. That allows the Trust to buy good companies and watch them grow in value. This will result in good, long term returns for the Trust and lots of annual income being paid to the Nation.

Another very important point to note is that the Trust holds stocks that pay dividends and alternative investments that pay interest. An estimate of the total cash yield of the Trust is 3.56%. This means that every year, the Trust makes about (\$120 million X 3.56% =) \$4.2 million in real dollars. This is money that can be paid out to the Nation or reinvested in shares (especially if they are on 'sale'). In other words, the Trust is getting paid while we wait for the markets to improve, which they always have.

I know this is a time of great uncertainty, so if there are any questions or concerns, I am available for a Zoom meeting at any time, day or night.

ANNUAL VEGETATION MANAGEMENT PROGRAM

Each year, CN is required to manage vegetation on its right-of-way. Managing this vegetation contributes to mitigating fire risks and enhances the efficiency of inspection of track infrastructure. The spray program is not being done for aesthetic reasons.

To ensure safe railway operations, CN will conduct its annual spray program on its rail lines in the province of Ontario. A certified professional (Davey Tree Expert Company of Canada, Ltd., 1-800-465-6367) will apply herbicides on and around the railway tracks (primarily along the 24-foot graveled area/ballast). Product requirements for setbacks in the vicinity of dwellings, aquatic environments and municipal water supplies will be met.

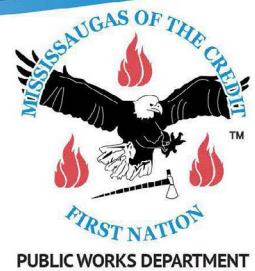

Public Works Department (PWD) is conducting our twice-yearly clean up event which occurs in April and October. Details of this April's event will be as follows:

1. Garbage bags (5 bags per bundle) & one (1) pair of gloves for each household participating will be available for pick-up by contacting Jeremy Tapper (519) 732-3058. Filled garbage bags can be placed at roadside for PWD staff to collect during morning check of road duties.
2. All PW Staff will split shifts as follows:
 - a. PWD will alternate staff starting April 14th through to April 17th to control access and direct members to appropriate bin for drop off (9:00am to 6:00pm)
 - b. **CLOSED Friday April 18, 2025, Good Friday**
 - c. PWD will alternate staff on April 19, 2025, to control access and direct members to appropriate bin drop off (9:00am to 3:00pm)
 - d. **CLOSED Sunday April 20, 2025**
 - e. PWD will alternate staff starting April 21st through to April 25th to control access and direct members to appropriate bin for drop off (9:00am to 6:00pm)
 - f. PWD will alternate staff on April 26th, 2025, to control access and direct members to appropriate bin drop off (9:00am to 3:00pm)
 - g. **CLOSED Sunday April 27, 2025**
 - h. PWD will alternate staff on April 28th, 2025, to control access and direct members to appropriate bin drop off (9:00am to 3:00pm)
3. **All waste is to be pre-sorted for a seamless drop off upon entering depot.**
4. All PWD staff will have high vis safety vests, gloves, and footwear at drop off location.
5. **MCFN members will be required to show their status card prior to entry, will remain in their vehicles until they are directed to the proper bin for unloading of waste.**
6. **There will be no congregating of people during the drop off (monitored by all staff on site)**
7. **MCFN members will be directed to the designated bin and will unload debris quickly to reduce wait times of others.**
8. **PWD staff will be present to organize drop offs and control of vehicular traffic flow in/out of drop off location.**
9. **Drop off location will only be at Solid Waste & Recycling Depot along Lagoon Road location.**
10. PWD to arrange for two (2) forty-yard bins (regular household waste)
11. PWD to arrange for one (1) forty-yard bin (scrap metal)
12. PWD to arrange for one (1) forty-yard bin with no restrictions (construction debris)
13. PWD Staff will have the backhoe during this event to compress debris in preparation for transporting and emptying. Each bin will be emptied weekly in preparation for the weekend drop offs by band members.

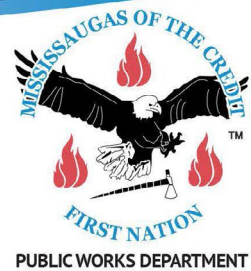

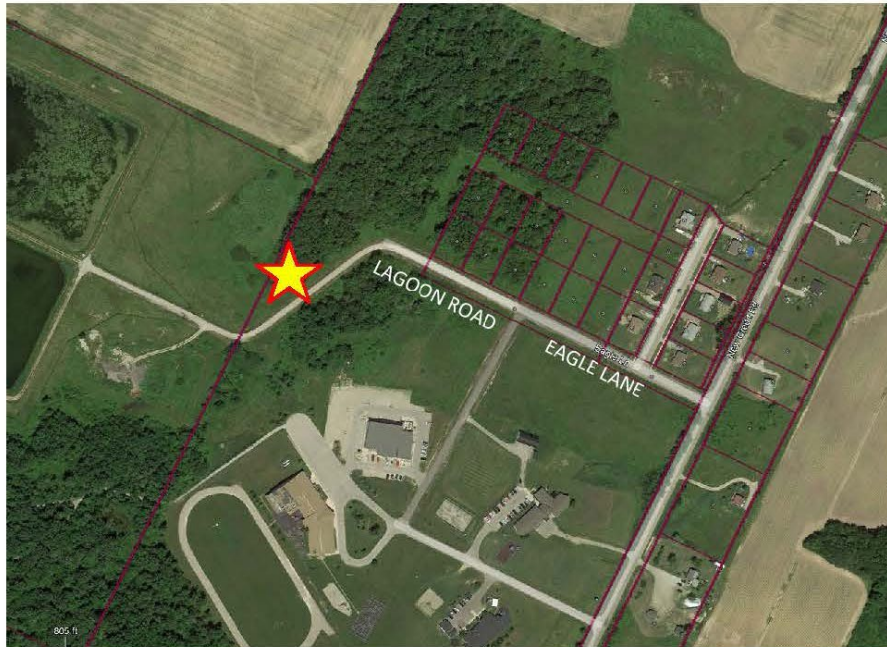

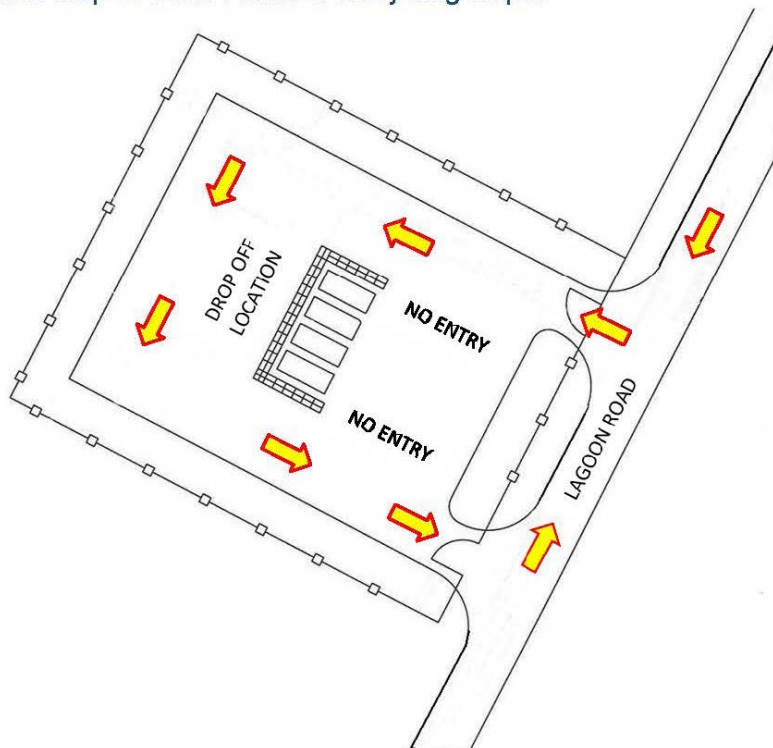

Life Events of Registered MCFN Members

Birth

In order for your child to be registered on the Mississaugas of the Credit membership list you must register the birth with Indigenous Services Canada (ISC). You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Only those entitled to registration on the MCFN membership list will be registered. ISC will notify you if your child is not eligible for registration.

Marriage

To register your marriage you must submit a request for amendment form, a copy of your marriage certificate and copies of your identification showing your married name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Divorce

To register your divorce you must submit a request for amendment form, a copy of your divorce certificate and copies of your identification showing your maiden name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Name Change

To register a name change you must submit a request for amendment form, a copy of the name change certificate and copies of your identification showing your new name. You can submit all required documents to the MCFN Lands & Membership Department or mail directly to ISC.

Death

When a Mississaugas of the Credit member passes away the death must be registered with Indigenous Services Canada. If a death is not reported the deceased individual will remain on the MCFN membership list. You can submit a death certificate to the MCFN Lands & Membership Dept. or to ISC.

Overview of Sections 6(1) and 6(2) of the Indian Act



6(1)(a) - Entitlement of person who was registered or entitled to be registered on or before April 17, 1985

6(1)(a.1) - Reinstatement of individuals whose names were omitted or deleted from the Indian Register, or a band list prior to September 4, 1951.

6(1)(a.2) - that person meets the following conditions:

(i) they were born female during the period beginning on September 4, 1951 and ending on April 16, 1985 and their parents were not married to each other at the time of the birth,

(ii) their father was at the time of that person's birth entitled to be registered or, if he was no longer living at that time, was at the time of death entitled to be registered, and

(iii) their mother was not at the time of that person's birth entitled to be registered;

6(1)(a.3) - that person is a direct descendant of a person who is, was or would have been entitled to be registered under paragraph (a.1) or (a.2) and

(i) they were born before April 17, 1985, whether or not their parents were married to each other at the time of the birth, or

(ii) they were born after April 16, 1985 and their parents were married to each other at any time before April 17, 1985;

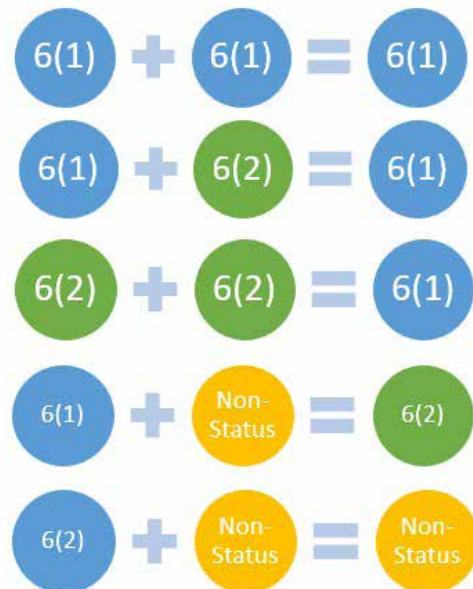
6(1)(b) - Entitlement for individuals who are members of a group declared to be a Band after April 17, 1985

6(1)(d) - Reinstatement for an individual who was enfranchised by voluntary application prior to April 17, 1985

6(1)(e) - Reinstatement for an individual that was enfranchised prior to September 4, 1951 for reasons of living abroad for 5 or more years without the consent of the Superintendent General or becoming ministers, doctors, lawyers ("professionals" only until 1920)

6(1)(f) - Entitlement for children with both parents entitled to registration

6(2) - Entitlement for children when only one parent is entitled to registration under 6(1) and the other parent is not entitled to registration.

A month of connection, learning and growth:

March brought a beautiful experiences, as we had participants spanning in age range, with our youngest being under a year old. It was heartwarming to see the natural bonds formed as participants took on the roles of "aunties" and "uncles," bringing a sense of nurturing and medicine to the group as we came together to connect with traditional plant medicines.

We were able to host our first session for the Kiinwi gdanwewinin'naa an Anishinaabemowin Language group and we are very excited to keep providing the space on a regular monthly basis.

Our weekend event, led by Ash Monture, saw a large turnout where we created protection sprays. This hands-on workshop brought our community closer and gave everyone a chance to dive deeper into the power of plant medicines.

March Break Camp was a truly special experience. It blended generations, with adults reconnecting with their inner child alongside the younger participants. We explored medicines during a walk on our property, meditated, painted, and learned how to incorporate these teachings into our personal care routines.

A proud moment for our staff came when one of our younger participants shared how they planned to teach their mom what they'd learned about the medicines at home.

We ended the month with our Drum Group lead by Jai King-Green who does a beautiful guide guiding us to find our voices.

We are grateful for these moments of connection and for the opportunity to bring people together, retracing our steps and creating a safe space where we can truly bond as a community.

Measles Update



What is Measles?

Measles is a highly contagious infection caused by the measles virus.

Measles spreads easily through the air. It is passed in tiny droplets when an infected person coughs, sneezes, or breathes. It can survive in the air for up to two hours.

A person with measles can spread the infection to others four days before to four days after the rash starts.

Signs and Symptoms

Symptoms of measles can develop 7 to 21 days after exposure to the virus. If you have had contact with someone who has been diagnosed with measles, it is important to monitor for symptoms for 21 days after your last exposure.

What should I do if I have symptoms of measles?

If you or your child are experiencing measles symptoms, stay home and contact your healthcare provider immediately to discuss follow-up recommendations. Do not attend work, school, public places or social activities.

If you were at these locations during these times, were born in 1970 or later, and are not up to date with your vaccinations, please contact your primary healthcare provider or call public health at 519-753-4937 ext. 454 or 905-318-6623 ext. 3438.

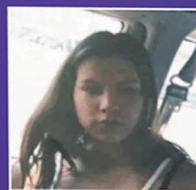
