Exhibit Criteria

Artists are invited to submit up to 3 pieces of artwork for consideration. The application will ask the artist to provide: Artist's name, title of work, medium, price, size, brief bio and description of piece, as well as a photo of the work to be displayed. Please closely review the outlined criteria below before submitting your artist application:

- All artwork must be in 'ready-to-hang' condition.
 - Artists are asked to ensure their work is securely wired for hanging, using the gallery's track system on the walls
- There are no size limits for works
- Artwork of all mediums are eligible including, but are not limited to, 2-D paintings, drawings, prints, photography, and mixed media. Textile, jewelry, installation and sculptural pieces are also invited providing they can hang on the gallery's track





- system and that they do not extend more that 14cm from the wall when hung. Please note that the RHCPA does not have any display cases.
- The exhibit is open to all levels of artists (student, emerging, mid-career and established).
- Artists are invited to sell their work at the exhibition. All funds (100%) from sales completed during the exhibit will remain with the artist. The artist is responsible for managing sales during the exhibit.
- If the work is for sale, the artist may provide contact information (email, phone number, artist website ect.) on the artist label which directs the public to contact them should they be interested in purchasing the art. The City will create the artist label.
- Artists will be contacted after this date once all the submissions have been reviewed.



Framing Example: To ensure the safety of works such as jewelry, the City recommends using a shadowbox frame to ensure works are secured to the wall.

Exhibit Logistics

Transporting of Artwork from Hagersville to Richmond Hill

- Artists may select the option that best fits their transportation needs:
 - Artist will deliver their artwork to the RHCPA on Monday, May 26 between 10am-12pm. Artists will be reimbursed for mileage.
 OR
 - 2. City of Richmond Hill will transport art from MCFN Community Centre to RHCPA. For this option, artists are required to drop off their artwork to the MCFN Community Centre at a predetermined date and time.
- Return of Artwork from Richmond Hill to Hagersville
 - After the completion of the exhibit, the artwork will be returned using the same process selected as above.
