The Senior Data Analyst will be a member of the Research and Data Management team and report directly to the Director of Research and Data Management.

DUTIES & RESPONSIBILITIES:

The Senior Data Analyst guides research and surveillance at the Chiefs of Ontario. This includes advising on the infrastructure needed by Chiefs of Ontario to support regional and community-level First Nations surveillance and research. The Senior Data Analyst will work with the Senior Lead for Research and Data Management, developing the Regional Health Survey report as well as working with communities that require their data extracted for community reports. The position also involves collaborating with, and providing advice, to other departments within the Chiefs of Ontario on data projects.

Duties:

- Establish regional processes for ongoing monitoring of First Nations health and wellness in Ontario (including development and implementation of meaningful metrics related to health and wellness)
- Develop processes to support community-level surveillance
- Write and develop policies, processes and protocols related to research
- Monitor and improve the quality of research within the Chiefs of Ontario
- Ensure First Nations data managed by COO and/or its partners aligns with OCAP® principles
- Serve as team member and/or co-investigator in studies that may be led by others, develop contacts within partner and government agencies and build COO's reputation as a competent and reliable partner, represent COO in external networks and projects
- Write successful proposals for funding, design effective studies, be an integral part of research teams as requested/needed
- Analyze data, facilitate interpretation of data analyses, prepare reports and publications as needed
- Ability to translate research and data into accessible language and formats
