Ogimaa-Kwe received a letter from the Survivor’s Secretariat in which it was stated that the Survivors’ Secretariat is launching our Orange Shirt Day Fundraising Campaign ahead of Orange Shirt Day on September 30. As in previous years, 100% of the proceeds from this campaign will go directly towards supporting the work of the Survivors’ Secretariat to Bring the Children Home.

The Survivors’ Secretariat has received no new federal funding for the 2024/2025 fiscal year, and our 2025/2026 application is still pending. Community support is more important than ever. Your participation can help ensure that we are able to continue our work to uncover, document, and share the truth about the Mohawk Institute.

Orange Shirt Day honours Indigenous children who were sent to Indian Residential Schools and acknowledges the lasting impacted inflicted on Survivors, their families, and communities.

Survivor’s Secretariat is asking for a donation.
