#### AGENDA ITEM NO. 6 - COMMUNITY CENTRE FLOORS (AS)

Councillor AS noted in her Briefing Note that the current floor in the Community Centre has begun peeling up/tearing in high traffic areas. At recent meetings/events, Seniors have tripped up on some of the raised pieces of flooring. This was observed by myself and others at a recent Community meeting.

The Public Works Department Community Centre Caretaker (Drew Kennedy) has said that he has already added this to the list of items needing replacement and has expressed this to the appropriate people. I discussed this matter with the Director of Public Works, and we agreed to work toward it.

The Public Works Director has been away for a significant period of time so I went ahead with this initiative as it has only gotten worse and **is a safety issue**. The caretakers have sourced 4 quotes from multiple companies to replace the floor throughout the building. Each one with its own pros/cons. They explored vinyl, carpet, tile, and rubber.

The recommendation is to hire Alexanian for the Stage floor for \$25,985.00 and Suburban Carpets Inc. for the remainder of the building at \$85,608.89.

The Health & Safety Committee will inspect when completed.

#### **MOTION NO. 8**

#### AGENDA ITEM NO. 7 - PUBLIC WORKS BUILDING EXTERIOR UPGRADES (AS)

Councillor As noted in her Briefing Note that the Public Works workshop building exteriors are deteriorating, leaking, and are full of patches/plyboard to fill existing holes. These buildings are old and need new siding.

The Public Works Department has received a quote from the company who just completed the newest build (the Grounds building) (Braemar Building Systems) – the reason for this sole source is to ensure that the buildings will match (finally), and because they are sure of the quality. The quote is to re-side all 3 buildings to match the Grounds Building which includes new metal siding, trims, and gutters.

Councillor As noted in her Briefing Note that we have all suffered the frustrations of the technology struggles at the Community Centre. Though the PWD has done a great job at revamping the technology, the Microphones themselves are now due for an upgrade.

The quote to upgrade the microphones is sources from the company who did the sound upgrades throughout the Nation as well as the Community Centre – Hamilton Video & Sound. This is for 5 wired microphones (band/Christmas concerts/performances) and 4 Digital wireless microphones (presentations, community meetings, etc), as well as the wiring for the existing monitors.

Councillor LM would like to apply to the MNCFN Community Trust for \$50,000.00 and to create an Emergency Fund Policy for the people who do not fit the low income criteria.

Councillor LS stated that this should be a health and social issue.
