# AGENDA ITEM NO. 9 – PRESENTATION BY GARY MIEDEMA & ADRIANA CHARTRAND (EF)

Gary Miedema stated that he works in heritage places. He would like to work with MCFN regarding any ideas that MCFN may have in the City of Toronto.

Councillor LS informed that the Host Community is Toronto for us and we need to set the foundations. He added that he takes issue with others that say "this is our land!" We are the rights holders, not stake holders. The Haudenosaunee are recognized as the Host Nation, when they are not.

Ogimaa-Kwe informed that we have 62 municipalities in our Traditional Territory and they are asking for our help.

Councillor EF questioned if there is anyone who could meet one on one or with a Committee?

Councillor LS inquired what information has been compiled and dedicated to MCFN? Also, how would you differentiate between us and others? Adriana Chartrand answered that they will work on a book and maps, and illustrations and glimpses from the past.

Councillor VKJ inquired what information do they have and where do they get it from? For example, the resources you are putting into the project. Gary answered that they have information from the Traditional Knowledge and Land Use Coordinator (Darrin Wybenga).

Councillor LS mentioned that his great grandfather, Peter Sault, had a pharmacy business in the City of Toronto in the 1840's. Peter Sault did not move with the people to New Credit as he tended his business. Gary replied that he would like to hear more stories like this from the past.

Councillor EF volunteered to work with Gary and Adriana to arrange something with the Community.

Ogimaa-Kwe informed that the Senior Director of Intergovernmental Affairs has a good grasp on the burial sites in Toronto. He could be a contact also.

Gary Miedema and Adriana Chartrand were thanked for their presentation and left at 11:00 am.

**AND WHEREAS** there remains an urgent need to proceed with the acquisition of a tractor to support the corporation's ongoing development and operations;

**AND WHEREAS** the following comparable tractor quotes have been reviewed and considered:

- **John Deere 5100E** \$75,900
- **John Deere 6115M** \$109,900

AND WHEREAS a 2014 John Deere 6125M tractor has been identified as the most suitable and cost-effective option for purchase from Walnut Grove Farms Ltd., PO Box 568, Hagersville, ON; (Former property Owners)

**BE IT RESOLVED THAT** the Board of Directors of Corporation 1001076350 Ontario INC. hereby approves the release of **sixty-five thousand dollars (\$65,000)** from the corporate business account ending in **1808**;

**AND THAT** these funds be used for the immediate purchase of the **John Deere 6125M** tractor; **AND THAT** this matter be deemed urgent and prioritized due to the delay caused by the change in staffing.

## AGENDA ITEM NO. 13b) - TEXTS OF MCFN TREATIES (LS)

Councillor LS noted in his Briefing Note that this item is about enhancing public awareness of the Mississaugas of the Credit First Nation (MCFN) Treaties (1781 – 1820) by making their texts more publicly accessible.

MCFN has a long history of Treaty Agreements with the Crown, covering approximately 3.0 million acres of land in Southern Ontario. These Treaties are fundamental to MCFN's historical and legal relationship with the Crown, yet they remain largely inaccessible to the general public.

At present, the text of these Treaties is stored within the Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) website. However, this platform is not widely known or easily accessible to the public. As a result, awareness and understanding of these treaties and their ongoing significance, are limited. Providing public access to these documents would promote education, transparency, and a greater appreciation of MCFN history and treaty rights.
