Food Security & Enrollment Incentive (2025-2026)

This is an annual application process for the 2025-2026 school year.

The **Food Security** and **Enrollment Incentive** provides funds for all MCFN secondary students living both on and off First Nation Location 40A.

Students are encouraged to have a personal bank account for the purposes of monthly electronic fund transfers.

Food security payments will be based on the actual number of days of school attended.

Support	Amount
Food Security	\$10.00 a day
Enrollment Allowance	\$50.00 a month

Eligibility Requirements:

- ☐ Student is a registered Member of the Mississaugas of the Credit First Nation.
- ☐ Student is regularly/actively attending school

Procedure:

- Provide details of where you are attending school; and confirmation of current attendance (Monthly attendance record usually available from the Guidance office).
