**AGENDA ITEM NO. 5 – AIAI CHIEFS COUNCIL – BRIEFING NOTE DATED MONDAY, JULY 21, 2025 FOR DISCUSSION (CS)**

Councillor LS provided the following Briefing Note to Council from the Director of Operations (Geoff Stonefish) from AIAI:

The purpose is to provide information to the AIAI Chiefs regarding the proposed funding cuts by Prime Minister Carney, specifically to Indigenous Affairs Canada and Crown Indigenous Relations and Northern Affairs.

The Prime Minister has recently directed his Cabinet Ministers to seek savings and to cut operational spending by 7.5% for the 2026-2027 fiscal year, 10% for 2027-2028 and 15% in 2028-2029.

- No proposed cuts to transfers to the provinces for health and social programs, pensions or old age security, child care, pharma care and dental care.
- Previous to this announcement ISC had already started to implement a planned funding cut of \$5 Billion over the next three years.
- Carney's 15% cut would be over and above ISC planned reduction.
- CIRNAC will also cut funding by 15% over the next three years.
- Funding reduction plans are due to be completed before the next federal budget which will likely be in the fall of 2025.

Regarding internal structuring of ISC:

- ISC has undertaken a “Sustainability Review Strategy which is a three-year plan to address priorities and also includes an internal review and restructuring of the Ministry. ISC has completed an internal restructuring and will be implementing this as of September 2, 2025.
- A major change will be the implantation of a new Regional Delivery Sector which consolidates the management of First Nation and Inuit Health and Regional Operations. This seems to be reversing efforts over the years to separate FNIHB from ISC Operations.
- The overall goal of this restructuring is to increase efficiency to administration, programs and services which at the end of the day will result in cost savings for the Ministry.

As mentioned earlier, ISC had proposed \$5 Billion in funding reductions prior to the Prime Minister’s announcement. The current budget of ISC is approximately \$27.2 Billion, which is the second largest budget of a government Ministry, ISC has forecast a reduced budget of \$25.3 Billion for 2025-2026, \$21.4 Billion for 2026-2027 and \$20.1 Billion for 2027-2028 for a total reduction of \$5 Billion over the next three years.

Councillor LS stated that for Child and Family Services, land claims etc. the government will eventually tell us to use our own source revenue. Across the board, lots of staff will lose their jobs. He also stated that our big issue is that royalties were not paid to us.

Councillor LS and Ogimaa-Kwe are taking responsibility to understand budget cycles which is due in October.

Councillor LS stated that this information is more for the Chief Administrative Officer. All departments will need to know where the funding budget cuts are going to be. Councillor LS will be meeting with the Chief Administrative Officer following this meeting regarding upcoming funding cuts.

On another note, Councillor LS reiterated that Jordan’s Principle has been abused.

#### **AGENDA ITEM NO. 6a) – GUN USAGE ON MCFN FIRST NATION (JH)**

Councillor JH brought this item to the Council Table as he has somewhat of a concern regarding gun usage after hours. Police were called on the weekend regarding shots being fired but they (Police) did not know what to do.

Councillor EF reiterated that years ago there was some kind of discussion on gun law. However, MCFN Member Carolyn King informed that there was too much push back from the Community and not much was done.

Councillor AS stated that there are signs around the First Nation about when guns can be used. Councillor LS added that we need to post gun control in our Newsletter as well.

Senior Director of Intergovernmental Affairs stated that the role of the Administrator is signing off on Ontario Works applications.

**AGENDA ITEM NO. 13 – PRESENTATION BY THE ASSOCIATION FOR NATIVE DEVELOPMENT IN THE PERFORMING & VISUAL ARTS (ANDPVA) (LM)**

Kelly Hashemi from the Association for Native Development in the Performing and Visual Arts (ANDPVA) was invited to give a presentation to Ogimaa-Kwe and Council by Councillor Leslie Maracle.

Everyone was introduced.

Ms. Hashemi highlighted her report and noted that ANDPVA serves as a haven to nurture Indigenous peoples' traditions, stories, and cultures; provides a cultural lens for Indigenous artists and audiences to see themselves reflected back; is dedicated to raising awareness about gender-based violence (GBV) and to suggesting that traditional teachings heal and prevent GBV; provides safe spaces for conversations and education about GBV.

The objective of ANDPVA is to build an understanding of stereotypes and how they perpetuate GBV in the community, and to cultivate ownership in developing policy and offering services in the community to end violence.

The goal is to increase awareness around GBV, brainstorm new approaches to creating awareness and recommendation for new policies, and proposing resources available in the community to help implement change.

ANDPVA uses Sharing Circles and Teachings.

Councillor LM noted in her Briefing Note that they (ANDPVA) would like to come to MCFN to conduct Sharing Circles and Teachings over two days in which we will conduct a survey to establish a baseline for gender-based violence attitudes in the community as well as conduct an audit with a policy analyst to learn more about the community.

Councillor LM also stated that we can use this project in a lot of our departments in the organization.
