## AGENDA ITEM NO. 15b) – FIRST NATIONS WITH SCHOOLS COLLECTIVE (FNWSC) – VALUE OF ENGAGING GOVERNMENT WITH SUPPORT OF REGISTERED LOBBYISTS (LESLIE WHITE-EYE) (SENIOR DIRECTOR OF OPERATIONS SPOKE TO THIS ITEM)

Leslee Whie-Eye noted in her Briefing Note that as part of the two pronged approach to reach an agreement with the Government of Canada, the FNWSC is requesting approval to engage StrategyCorp, a strategic advisory and government relations firm to perform specific lobbying activities that will assist in facilitating further negotiations with the Crown.

StrategyCorp is able to provide strategic advisory services without registering as lobbyists on behalf of FNWSC, such as drafting letters, Briefing Notes, and advising on who in different ministries that FNWSC should contact once those individuals are in place. However, FNWSC is unable to benefit from the full range of StrategyCorp's value and advance the Collective's objectives through its relationship with Ministers, political staffers, and senior bureaucrats in registerable activity. The excluded ability to directly email, call, and text current and former colleagues and acquaintances or to attend meetings alongside FNWSC reduces the "soft power" ability of StrategyCorp to influence the government on behalf of FNWSC.

## AGENDA ITEM NO. 15f) – IN-CAMERA ITEM – EMERGENCY TREATMENT FUND (ETF) 2024 – FUNDING OPPORTUNITY AND PROPOSAL FOR MISSISSAUGAS OF THE CREDIT FIRST NATION (MCFN) (HEALTH DIRECTOR)

Director of Health Services (Maggie Copeland) noted in her Briefing Note that the Emergency Treatment Fund (ETF) is a federal funding initiative aimed at supporting urgent and financially feasible projects that address the opioid overdose crisis and other substance use issues with Canadian communities. For 2024, the ETF anticipates funding projects that can be completed by March 31, 2025, with priority given to proposals that address urgent needs and are project ready.

The key goals of the EFT include increasing access to substance use services and improving the capacity of communities to respond to the overdose crisis. Indigenous communities, which have been disproportionately impacted by the opioid crisis, are encouraged to apply for this funding to develop culturally relevant, community driven solutions to substance use challenges.

Director of Health is taking care of this initiative.

Councillor FS questioned if some of these dollars could go to building a sweat lodge.
