AGENDA ITEM NO. 7 – PRESENTATION ON TEAMS – INTRODUCTORY MEETING WITH DEREK GORING OF NORTHCREST YZD

lan and Derek provided a verbal update regarding the Downsview Development Project, but they are also here just to see the First Nation and what MCFN is all about.

Ian stated that they (Northcrest) would like to further their partnerships with MCFN.

The Downsview Project includes 370 acres and used to be an airport.

Councillor LS suggested that Council should visit the site and make a promotional video. Ian and Derek were in agreement.

AGENDA ITEM NO. 8 - PRESENTATION BY ZISHAN CHAUDRY (GRANT WRITER)

Zishan noted in his Briefing Note that he would like to present to Chief and Council the Canada Housing Infrastructure Fund (CHIF), a funding opportunity that is aimed to support the enhancement of MCFN's water and solid waste infrastructure, thereby facilitating future housing development within the Community.

The Government of Canada, through Budget 2024, established the Canada Housing Infrastructure Fund (CHIF) with a commitment of \$6 Billion over ten years. The fund aims to accelerate the construction and upgrading of essential infrastructure, specifically drinking water, wastewater, stormwater, and solid-waste systems, to directly support the creation of new housing and increase community densification.

Zishan noted that Ogimaa-Kwe and Council can also help set up the reporting of these dollars, should the application be approved.

On another note, Ogimaa-Kwe noted that consideration for one person to drive the Culture and Events Unit is important.

Further, Councillor AS will seek quotes for traffic signs in Ojibway and, a person from Curve Lake will do the translation.

DIRECTION NO. 3

That the Mississaugas of the Credit First Nation (MCFN) Financial Planning & Fiscal Oversight Council directs Councillor Ashley Sault to seek quotes for traffic signs (in Ojibway language). The language person from Curve Lake will be engaged regarding the language. Further, Councillor AS will bring forward the Motion that was approved by Chief and Council last term, which former Councillor Andrea King brought to the Council Table.

This funding will be instrumental in advancing MCFN's infrastructure capabilities, thereby supporting the community's housing development goals and enhancing the quality of life for current and future members.

Potential items to ask for funding through CHIF to unlock community development:

- Engineering studies to assess the capacity of existing water and wastewater infrastructure and identify upgrades required to support new housing;
- **Design and costing** for system expansion or connection of unserviced parcels identified in MCFN's land use or housing plans;
- **Servicing strategy** for future residential zones, including stormwater and solid waste management;
- Project management and coordination to advance shovel-ready infrastructure tied to housing creation.

Next Steps:

Support from MCFN Chief and Council, and Administrative Leadership, to:

1. **Engage Community Stakeholders:** Consult with community leaders to ensure the projects align with their needs and priorities, and define scope of work to best address gaps that exist.

By pursuing this funding opportunity, MCFN can proactively address infrastructure challenges and lay the groundwork for sustainable community development.

<u>AGENDA ITEM NO. 6 – DONATION POLICY – ADDITIONAL INFORMATION (LM DIRECTOR)</u>

LM Director noted in her Briefing Note that she would like to submit an application to the MNCFN Community Trust regarding the Donation Policy for the 2025-2026 fiscal year.

Council requested additional information regarding funding that had been denied to MCFN Members as a result of depletion of funds. Further Council requested additional information on how the LM Director arrived at the figure of \$80,000.00 to be requested from the Community Trust.

The total amount received from the MCFN Community Trust was \$70,000.00. This amount was split between Lesson/Registration reimbursement (\$35,000) and Event Funding(\$35,000). By early December 2024, the lesson/registration portion was fully utilized. By early February 2025 the event portion was fully utilized. There were 17 applications that were not processed due to a lack of available funds. These applications totaled \$9,085.11.

Since the amount of denied funding was just under \$10,000.00, it was determined that the request would be \$80,000.00.

Councillor EF suggested raising the application for funding to \$100,000.00 and if more dollars Are needed the LM Director can bring a request to Council. She also added that something Should be put in the policy that when the dollars run out bring a request to Council for more money.

Ogimaa-Kwe stated that the Donation Policy should be moved to another department.

It was pointed out that the donation dollars should not be given to the same people year after year.

Councillor VKJ stated that all this data should be added to the Annual Report.
