## AGENDA ITEM NO. 8 – START ADDITION TO RESERVE PROCESS ON 4136 HIGHWAY NO. 6 PROPERTY (JH)

Councillor JH noted in his Briefing Note that he is providing an update on the steps required to initiate the Addition to Reserve (ATR) process for the newly acquired property located at 4136 Hwy 6, Hagersville, ON.

By way of background, the property at 4136 Hwy 6, Hagersville, ON, N0A 1H0, was purchased on December 16, 2024 with the possibility to incorporate it into reserve lands.

The ATR process is governed by specific guidelines under Indigenous Services Canada (ISC) and involves federal, provincial, and municipal consultation.

Legal Counsel has been engaged to ensure compliance with the legal and procedural requirements for the ATR process.

While it has been suggested to start the ATR process, it can be stopped at any time if necessary.

Currently, Legal Counsel has been provided with relevant property details and has been asked to prepare a roadmap for the ATR process.

Questions from Legal Counsel require clarification to proceed further.

If approved, a Band Council Resolution (BCR) will need to be signed to formally initiate the ATR process. This BCR will be ready for signature at next week's meeting.

#### AGENDA ITEM NO. 9 - NATIVE CANADIAN CENTRE (EF)

Councillor EF noted in her Briefing Note that Gary Miedema of Three Sisters Consulting is requesting information from MCFN regarding compiling information on properties, building spaces or places etc. in the City of Toronto in order to prepare a document that can be shared to ensure specific areas could be marked as historical.

Mr. Miedema is requesting a meeting with Ogimaa-Kwe and Council before he meets with people at the Native Canadian Centre. MCFN will need to give their permission for the Native Canadian Centre to speak with Mr. Miedema as he (Mr. Miedema) is including First Nations, Metis, and Inuit Communities.

Ogimaa-Kwe noted that the only legitimate Metis under Section 35 is the Metis from Manitoba.

MCFN is requesting more information from Mr. Miedema on who exactly the Metis are.

### AGENDA ITEM NO. 12c) – FUTURE GENERATIONS FOUNDATION GRANT SUBMISSION 2025-26 (ZISHAN CHAUDRY – GRANT AND PROPOSAL WRITER)

Grant/Proposal Writer stated in his Briefing Note that he is providing an overview and recommendation for approval regarding the proposed "Language and Culture: Revitalization and Practice in the Mississaugas of the Credit First Nation" initiative for the fiscal year 2025-2026.

MCFN has drafted a grant proposal requesting \$200,000.00 in funding from the Future Generations Foundation to support a one-year program focused on language and cultural revitalization. The initiative aims to address the historical disruptions to language transmission caused by colonial practices such as Residential Schools, the Sixties Scoop, and Indian Day Schools.

Chief Administration Officer advised that this item should go through the Senior Director of Intergovernmental Affairs, as there are problems with Pillar Leads taking on projects. Councillor VKJ disagrees as she works with youth groups/camps.

Councillor FS stated we should just apply for the grant and get moving.
