#### AGENDA ITEM NO. 7 - CHICAGO FIELD MUSEUM (EF)

Councillor EF noted in her Briefing Note that during the past two years the MCFN Artifacts Committee has been communicating with a representative from the Chicago Museum.

Representatives from the MCFN Artifacts Committee met with staff at the Royal Ontario Museum (ROM) in the fall of 2024. The staff from the ROM offered to assist our Nation in repatriating the artifact to the ROM to make an easier transfer from Museum to Museum.

What our Artifact Committee requires is a point person at MCFN approved by a letter of authorization. We require the letter to be signed by Ogiima Kwe Claire Sault to appoint Adam LaForme/Manager of Archaeology/Department of Consultation and Accommodation as the lead for our Nation, to work with staff from the ROM and the Chicago Museum.

Councillor EF noted that she will get the Consultant to prepare the letter.

Councillor LS stated that we need some kind of protocol for Chief and Council to understand.

Senior Director of Intergovernmental Affairs informed that the Terms of Reference, which is already completed, will dictate what needs to be done.

See Councillor LS's email below responding to Direction No. 2 above:

Good morning all;

As per direction from yesterday's Council meeting, I reached out to Chief's of Ontario's Director of Justice who has responsibility for all legal matters concerning Bill C-53 the controversial Self-Government legislation that Metis Nation of Ontario (MNO) was trying to ram through Parliament. As I understand, Bill C-53 is now dead, but that does not mean it will not resurrect itself in the future.

In this term of Council, MCFN has been on track to correct the lose land acknowledgement that has and still is circulating in Municipalities, cities and corporations throughout our historic treaty lands.

I was given direction from Council to ask for a draft support letter that would be signed off by Regional Chief Abram Benedict. The letter would confirm the 133 Ontario Chiefs position that MNO has no rights within the Province and more specifically in MCFN traditional treaty territory. To be clear, MCFN is simply asking for ORC to support our stand that the Metis have no jurisdiction in Toronto or any other region of Ontario. MCFN will have to draft our own letter to the City (Gary Miedema) with same messaging for Erma to deliver. Please review draft. Hope this helps Erma in her quest to finalize a position from MCFN.
