AGENDA ITEM NO. 6 – GOLF CANADA – 2025 CANADIAN OPEN (ML)

Senior Director of Intergovernmental Affairs (Mark LaForme) noted in his Briefing Note that Golf Canada has invited the Mississaugas of the Credit First Nation to participate in the opening events for the 2025 RBC Canadian Open and the 2025 CPKC Women's Open. The CPKC Women's open will be held at the Mississauga Golf and Country Club (the former site of the MCFN Mission Village).

The RBC men's event will be held in June 2025 at a golf course in Caledon. The CPKC women's event will be held in August 2025 at the Mississauga Golf and Country Club. An opening ceremony is planned for both events the day before the first day of each – Wednesday, June 4, 2025 for the men's event and Tuesday, August 19 or Wednesday, August 20 2025 for the women's event. Golf Canada would like the MCFN to attend and provide a welcoming at both opening events.

At the December 4 meeting, Mark LaForme informed the representatives from Golf Canada that the Mississauga Golf and Country Club was built on top of the former Credit River Mission Village belonging to the ancestors of the MCFN. There are also likely burials at this location, underneath the active golf course. Therefore, there are sensitivities which must be considered in how the MCFN responds to Golf Canada's request to participate in the women's event specifically.

Golf Canada requested feedback from the MCFN regarding how they wished to participate in the 2025 RBC Canadian Open by the end of January 2025, if possible.

It is suggested that the Working Group could include:

- A Representative for MCFN Administration (Drew Denton, Senior Director of Operations);
- Two Representatives from DOCA (Megan DeVries, Manager of Consultations, and Darin Wybenga, Heritage Interpreter);
- A Representative from Communications (Victoria Gray, Manager of Communications);

- A Representative from the City of Mississauga's Heritage Department (John Dunlop, Manager of Heritage, Planning, and Indigenous Relations), who volunteered and is familiar with the history and current land use of the location and may be able to offer additional insights; and, as Mr. Dunlop proposed;
- A Representative from Visit Mississauga, the City's tourism office who has recently prepared a submission to designate the Mississauga Golf and Country Club as a heritage site;
- A Knowledge Keeper will be added;
- A Youth Representative will be added.

AGENDA ITEM NO. 7 – TORONTO PURCHASE TRUST (EF)

Councillor EF noted in her Briefing Note that Georgina Villeneuve of Peace Hills Trust sent the following email:

“The taxable income is very close to the 4% mark [4,398,697] so I would say it will end up beating the 4%. The taxable income at the end of November is \$4,179,413 plus the income produced in Dec. If you take the gains it would add about \$1,022,598.”

We are still waiting for the approximate Membership numbers we will have by April 01, 2025, to determine how much the Wellness payment will be for April 2025.

The final decision on the amount the MCFN will be withdrawn from the Toronto Purchase Trust for the 2025 Wellness Payment/Payments, will be the decision of the MCFN Ogiima Kwe and Council.

Councillor EF noted in her Briefing Note that the Niagara Reinforcement Line (NRL) investment earns approximately \$200,000.00 (two hundred thousand dollars) every quarter, and the revenue is transferred to Peace Hills Trust to apply to the MCFN Toronto Purchase Trust.

In early 2025, a final True Up payment will be transferred to Peace Hills Trust to be applied to the Toronto Purchase Trust. The True Up will be around \$250,000.00 (two hundred fifty thousand dollars) to \$300,000.00 (three hundred thousand dollars).

AND FURTHER: The “True Up” payment will be forwarded to Peace Hills Trust to grow the Toronto Purchase Trust, will be transferred in early 2025. The “True Up” payment will be between \$250,000.00 - \$300,000.00 (two hundred fifty thousand and three hundred thousand).
