AGENDA ITEM NO. 8 – EMERGENCY ASSISTANCE FOR MEMBERS (LM)

Councillor LM noted in her Briefing Note that MCFN has an emergency fund policy for members who fit into the low income bracket or receive assistance from OW/ODSP, etc. We do not have help for our working members who experience trauma and need immediate assistance. This is discriminatory

As requested an emergency policy has been created. I am seeking approval or suggestions.

A new policy for emergency funding has been created and needs to be approved or revised for Councillor Leslie to apply to the Trust Fund and create an account with the Finance Team. This fund will be delegated to the Nation Well-Being Pillar 2 to maintain consistency for all members.

Councillor LS questioned what is deemed an emergency. We need a list of the information and we need parameters. Councillor AS added that natural disasters need to be added to the list.

On another note, Councillor LS reiterated that we want to create a long-term plan for topping up Seniors' incomes etc. The Community Trust should be utilized also.

AGENDA ITEM NO. 9 - CHILD & FAMILY SERVICES OF GRAND ERIE (LM)

Everyone was introduced.

Sally Johnson gave the following background information:

- Child & Family Services of Grand Erie is focused on reconciliation.
- There are five children in our care: two siblings in Simcoe, two at Six Nations and one in Oshawa.
- There are 17 ongoing files.
- We now have a Jordan's Principle Navigator in our office.

Regarding Customary Care, Director of Social Services (Yvonne Bomberry) is working on a policy so that children who are being apprehended could go to family or a Community member they know and trust and feel safe with, without severing the relationship.

Ms. Johnson requested Council's advice on customary care as we do have a protocol with MCFN. She also stated that they are trying to build a better relationship of how First Nations view the Children's Aid Society (CAS).

Ogimaa-Kwe informed that she has not seen a push in our Community for recruiting foster parents. However, Councillor LM says otherwise, and that there is a push for fostering.

Ogimaa-Kwe suggested doing an engagement with people who would step up. We could also send a notice to the Community,
