### AGENDA ITEM NO. 5 – SENIORS & YOUTH – INVITATION TO BE ON THE AGENDA THE FIRST TUESDAY OF EACH MONTH

MCFN Member Veronica Tobicoe (VT) informed that the Peacekeepers are off until Friday, May 6, 2025. Most of Council was not aware of this. VT also informed that there are only 4 Peacekeepers on duty and they are getting burned out. They (Peacekeepers) act as liaison with the OPP.

Councillor LM reiterated that the Peacekeepers Program is a Pilot Project until 2026. She further stated that the Peacekeepers are not on duty 24/7. Councillor AS then stated that the Community needs to know that the Peacekeepers are not working 24/7.

Councillor AS noted that there is a lack of communication between the Peacekeepers and Ogimaa-Kwe and Council.

Councillor VKJ stated that it will take the whole Community to make the Peacekeepers work, and we must give them a chance. She also reiterated that the Peacekeeper Coordinator (Krissa Staats) is on a six-month probation period. Councillor AS questioned who would be doing Krissa's evaluation. Councillor FS added that this is a new program and the kinks have to be worked out.

Councillor LM noted that we are waiting for a Project Manager to start building a place for the Peacekeepers.

Councillor LS informed that we need a background report, for example, what is good, what is not good and what needs to be fixed. Everything needs to be sorted out. Also, who is accountable to who? And what about structural issues?

Ogimaa-Kwe and Council agreed that a meeting would be scheduled.
