AGENDA ITEM NO. 4 - MATTERS ARISING FROM THE MINUTES

AGENDA ITEM NO. 5 – YOUTH COUNCIL TO MEET WITH OGIMAA-KWE AND COUNCIL (VKJ)

All were introduced to Ogimaa-Kwe and Council.

Darienne King is the Youth Council Coordinator and highlighted their handouts which were the Youth Council Terms of Reference and the Youth Council Code of Conduct.

Darienne stated that Youth Council would like to shadow MCFN Council/Pillar Leads. She also stated that Youth Council would like to set a date to meet with Chief and Council.

Ogimaa-Kwe suggested calling a Special Council Meeting specifically for meeting with Youth Council. Councillor LM suggested meeting in the new year after the election and holidays are over.

That the MCFN Regular Council directs the Chief Administrative Officer to supply copies of the 7 Generations Plan to Youth Council.

DIRECTION NO. 4

That the MCFN Regular Council directs the Chief Financial Officer to create a sustainable budget for the Youth Council.

DIRECTION NO. 5

That the MCFN Regular Council directs the Chief Administrative Officer to revise the Terms of Reference and Code of Conduct for the Youth Council, and bring back to the Council Table for approval.

Youth Council were thanked for their presentation and left at 9:45 am.

Archaeological Manager Adam LaForme joined the meeting via Teams at 9:45 am.

AGENDA ITEM NO. 6 - ARTIFACTS UPDATE ON BANDOLIER BAG (EF)

Councillor EF has been trying to repatriate the Bandolier Bag of the late Rev. Peter Jones since the fall of 2021 without much success. She stated that herself and Adam LaForme met with staff from the Museum Services at Fort York in Toronto to create a video on the task of repatriating the Bandolier Bag and other artifacts.

Councillor LS suggested contacting other First Nations and inquire how we can all get our property back from the US.

Senior Director of Intergovernmental Affairs informed that Quintin Lewis is a Professor and Curator of a museum in New York State and he may be able to assist in some way.

Council has agreed to acknowledge Councillor EF's report on the repatriation of the Bandolier Bag of the late Rev. Peter Jones.

AGENDA ITEM NO. 7 - REQUEST TO DISPLAY ARTIFACTS (EF)

Councillor EF noted in her Briefing Note that the Peace Pipe that was presented to the late Rev. Peter Jones is in storage at the Woodland Cultural Museum in Brantford, Ontario. A replica of the pipe was made for the MCFN Community Centre and one was made for the Visitors Centre at fort York.

The Artifacts Committee is requesting the original pipe gifted to the late Rev. Peter Jones be loaned to a museum in Toronto. Security for the transport of the Pipe will be put in place.

Councillor LS stated that we should have a list of all our artifacts that are stored at the Woodland Culture Centre. Councillor EF replied that everything is recorded on camera.

Further, the MCFN Artifacts Committee will ensure a proper document is created to loan the Peace Pipe to a museum in Toronto, Ontario for a period no longer than five years.

Ogimaa-Kwe answered that she and others will meet with the family and bring back to the Council Table more information and some figures.

Councillor JH highlighted a report that he brought back to the Council Table regarding the Addition to Reserve Update.

MCFN's ATR File continues to move forward with steady progress through ISC's established process. Key milestones have been met, and upcoming stages will focus on environmental assessment and municipal negotiations to advance the File toward final approval. Therefore, everything is proceeding like clockwork
