MCFN Member VT expressed her concern about the amount of drugs being abused in our Community. She also stated that there are no programs here to assist anyone who would like to get help. Her question is “How do we, as a Community, deal with this?”

MCFN Member RK added that even Native Horizons Treatment Centre (NHTC) does not have any programs to assist the Community. She would like to see NHTC do more for the Community, eg. a Detox Centre. Ogimaa-Kwe also noted that we need to do something! She suggested that perhaps we could hire someone to do something, but preferably, not someone from this Community.

Interim Executive Director of Operations suggested that Director of Health, Director of Social Services and Director of Lifelong Learning meet together to develop a comprehensive strategy to address addictions in our Community.

Director of Lifelong Learning noted in her Briefing Note that she is seeking Council to approve the expenditure of \$25,080.00 (Twenty-five Thousand Eighty Dollars and Zero Cents) to Lloyd S. King Elementary School before the commencement of the 2023-24 school year.

During the expansion of LSK, we had installed new lockers in kilim beige leaving the older side of LSK with the blue lockers. There was a vendor during the expansion installing the lockers but they had given us issues and we sought out a different vendor, Quality Stalls, to fix the previous work. We have obtained a quote from Quality Stalls and Canadian Washroom Products.

Based on the above, we are seeking permission to enter into a contract with Canadian Washroom Products in the amount of \$25,080.00 (Twenty-five Thousand Eighty Dollars and Zero Cents) which provides Lloyd S. King School to have all fixtures flush with expansion looks.

it is anticipated that approximately \$125,000.00 (One Hundred Twenty Five Thousand Dollars and Zero Cents) has been estimated to provide graduation awards to the students for their academic achievements. This amount requested is estimated to provide awards to both on and off the territory students.

AGENDA ITEM NO. 11 – NIAGARA REINFORCEMENT LINE UPDATE (EF)

Councillor EF noted in her Briefing Note that MCFN owns twenty percent equity in the Niagara Reinforcement Line (NRL). All revenue earned quarterly on the NRL, is electronically sent to Peace Hills Trust, to be applied to our Toronto Purchase Trust.

The NRL is a 76 km double circuit 230 kilovolt transmission line beginning at the Allanburg Transformer Station and ends at the Middleport Transformer Station.

The total amount MCFN earned on the NRL, for the period January 01, 2023-December 31, 2023 is \$1,224,200.00 (one million two hundred twenty four thousand two hundred dollars).

During the 2024 calendar year maintenance will be required on the NRL; (1) forestry and (2) additional bracing on the Tower Arms.

The maintenance on the NRL will reduce the revenue to be paid to MCFN during the 2024 calendar year. The cost of maintenance is not known at this time.

During the 2024 calendar year discussions will take place regarding a reduced inflation factor. Councillor EF's suggestion is to schedule Jeffrey Smith/Managing Director/Hydro One Indigenous Partnerships Inc. to give a presentation to Council regarding the cost of maintenance.

They (Toronto Fire Station 422 and the City of Toronto) also informed that this design is AI (Artificial Intelligence) generated. AI generated art does not properly reflect Indigenous History of the land, and is taking away an opportunity from Indigenous artists to showcase their talent and stories.

It is our recommendation to not approve the proposed design for this reason.
