AGENDA ITEM NO. 6 – MCFN FIRST NATIONS FINANCIAL MANAGEMENT BOARD PRESENTATION (JASON PELTIER)

Jason Peltier of the Financial Management Board zoomed in today to speak with Council about the Financial Management Board.

Below is an email from Mr. Peltier and what he is requesting from MCFN:

Aanii Hello Chief Sault, Sergey and Marlene Miigwech for the invitation to meet with Chief & Council this morning.

I attached updated BCR and Letter of Cooperation to include Ashley Sault on the signature block.

These two items are the main documents to be signed to get started.

- 1. Please have C/C review and sign the Band Council Resolution to request a formal review by FMB. (See Attached) This document represents Chief and Council's instruction to FMB for a review of their Financial Administration Law ("FAL")
- 2. Please have C/C review and sign the Letter of Cooperation with FMB. (See Attached) This is a legal non-binding document that provides us with the primary contacts designated to represent your community in the development of your FAL and support your First Nation in developing the capacity to meet their financial management requirements. Services are at no cost.
- 3. After we receive the above two documents we will send over a funding agreement. We will provide \$7,500 to offset legal costs associated with the review and development of the Financial Administration Law.

Accepting the transfer payment of \$25,000.00 from the Association of Iroquois and Allied Indians (AIAI) will help with:

- Program Materials
- Equipment costs
- Professional and/or Elder fees
- Honorariums for guest speakers, facilitators and/or chaperones
- Travel
- Accommodations
- Facility rentals
- Food & Supplies
- Funds to top up community-based plans for youth in community
- Office Supplies, Copying and Printing (Admin)
- Promotion & marketing materials

The funds will need to be expensed by March 31, 2025 and by accepting the funds Mississaugas of the Credit First Nation (MCFN) agrees to adhere to all requirements outlined in the agreement.

AGENDA ITEM NO. 10 - NCVGB QUOTA UPDATE (SED DIRECTOR)

DSED (Amanda Braun) noted in her Briefing Note that on March 21, 2024, the Intergovernmental Relations Council approved the Tobacco Quota Allocation Distribution for 2024/2025. New Credit Variety & Gas Bar (NCVGB) was allotted 15,853 cartons at that time.

NCVGB currently has (as of November 27, 2024) 9,500 quota cartons to purchase from Core-Mark before March 31, 2025. If these cartons are not purchased by March 31, 2025, the remaining quota cartons will be lost as they cannot be carried over in to the new fiscal allotment.

The DSED has already been contacted by one of the retailers asking if there will be a quota reallotment for this fiscal. If a re-allotment is approved, the DSED would reach out to all retailers to offer the approved number of quota cartons prior to sending the re-allocation information in to the Ministry of Finance.

Ogimaa-Kwe suggested selling the 9,500 cartons for \$1.00 extra on each carton.

DSED will get the mark-up on the cost first. This item will come back to the Council Table in the new year.
