MCFN Member Rebecca Hill informed that there are three students who live in Hagersville whose parents are struggling to find dollars for their children, and the parents cannot get funding from MCFN for off reserve students.

Councillor LS questioned how to close this gap.

MCFN Member Clyde King suggested using Jordan's Principle dollars.

Councillor VKJ informed that she had a grandson who is not even listed at Hagersville Secondary School.

MCFN Member Rebecca Hill suggested using cards instead of having to cash cheques.

**DIRECTION NO. 2**

MCFN Member Valarie King would like to know what is happening with the Cannabis File, as she has not heard of any follow up; and further, Youth need to know when they are on the Agenda; further still, Members want a forensic audit; and, how do we keep our Community safe; In addition, Valarie also stated that she would like some space on the Community Meeting Agenda.

Councillor LM answered that Ogimaa-Kwe and Council would like a month to answer all Valarie's concerns.

Councillor LS stated that all Valarie's issues are directed to the Directors. Ogimaa-Kwe and Council direct staff. He also added that we need to put some order to these meetings such as who is responsible for what.

Councillor FS noted that this is also a funding issue.

Interim Executive Director of Operations informed that our primary concern is the Jordan's Principle application/request which has already been sent for approximately \$3 Million dollars.

MCFN Member Valarie King reiterated that someone from this Council Table is working for another First Nation. She also questioned why the letter regarding the resignation of the MEC Committee was taken off the website.

Councillor EF would like an update on all the balances of the above accounts for 2023-2024.

Councillor LS reiterated that every issue MCFN Member Valarie King made was with staff. He questioned if we are dealing with incompetence. Ogimaa-Kwe answered that we have policy issues, hiring issues, gaps in communication, and the Finance Department should be putting out Monthly Financial Statements. Interim Executive Director of Operations added that we need to get a structure in place. Councillor EF added that our staff need training.

Ogimaa-Kwe stated that she does not want to cross the line with staff.

## **AGENDA ITEM NO. 9 – FISCAL OVERSIGHT COMMITTEE (FOC) UPDATE (AA)**

Executive Director of Finance/HR noted in her Briefing Note that the Fiscal Oversight Committee (FOC) meets to review the most current financial information and content for the organization to report to the Council as a whole. The May 2024 meeting was cancelled and will resume in June 2024.

The Fiscal Oversight Committee met on April 18, 2024, to discuss the financials as of March 31, 2024. The NCVGB financials were not included in the meeting package but have since been included in this report up to March 31, 2024. It was noted that these statements are in draft form as there are entries that are still required after meeting with departments to ensure that allocations, funding and deferred revenues have been recorded. The FY2023 audit is nearing completion and MNP is set to present the draft financial statements to Chief & Council at the June 18th Meeting. They are just finalizing their end of things and creating the statements to

bring forward for approval. Once this is approved, we will then be current with our finances and will be able to obtain an engagement letter for the next current year and be aligned with the normal auditing process and expect to have that completed by July 2024 for the FY2024.

The approved minutes of the meeting from March are attached for transparency of the meeting.

The draft Financials as of March 31, 2024 are also attached as requested by the Committee. These statements will be final once we have made necessary transactions to close out the year once everything has been recorded and prepared for the auditors.
