AGENDA ITEM NO. 5 – NEW CREDIT UNITED CHURCH & DINING HALL RENOVATIONS (EF)

Councillor EF noted in her Briefing Note that there are Members who have expressed interest in renting the Dining Hall for special events, but due to safety issues, the Dining Hall cannot be rented.

PW Director has estimated the cost to renovate it at approximately \$1 Million dollars.

In the event that Council does renovate, dollars could be used from the Community Development Fund, Gaming Dollars or dollars from Enterprise Fund.

It is important to discuss with the Chief Financial Officer the best funding source to be used.

Councillor JH stated that we can build a new building for a lot less. Further, we also need to think about maintenance upkeep. Senior Director of Intergovernmental Affairs noted that we would need a survey if we are going to rebuild.

Councillor AS stated that we should engage the Community. We would also need a Project Manager as we have no capacity to build. It is an asset that we own and should be using it as we are responsible for it. She suggested using culture dollars instead of own source revenue.

Councillor VKJ suggested asking Community Members to help.

Councillor FS noted that a feasibility study would not be necessary.

Ogimaa-Kwe stated that we should start to take action today.

AGENDA ITEM NO. 7 - BRANT COMMUNITY HEALTH CARE SYSTEM - INTRODUCTION OF NEW INDIGENOUS HEALTH TEAM MANAGER - MICHELLE BOMBERRY (LM)

Michelle Bomberry wanted to be on the Agenda to introduce herself and informed Council that she has been hired as a new Indigenous Health Team Manager at the Brant Community Healthcare System (BCHS). Her goal is to build a more welcoming and equitable visit for our people using BCHS. Currently, herself and Margaret Copeland (Director of Health Services at MCFN) sit on the Indigenous Advisory Committee with BCHS, and MCFN will now have a voice at the table.

Michelle informed that she also works with the Navigators. Ogimaa-Kwe informed that her nephew was in both the Brantford General and Hamilton General and there were no Navigators to assist him. Michelle answered that we need to do a better job at excellence of care. Ogimaa-Kwe further advised that Navigators names should be put in our Newsletter.

Councillor LM informed that MCFN is also trying to build relationships with other hospitals.

Michelle was thanked for her presentation and left at 10:10 am.

<u>AGENDA ITEM NO. 6 – 2024-2025 INDIGENOUS HEALTH EQUITY FUND ALLOCATION</u> (DIRECTOR OF HEALTH SERVICES – MAGGIE COPELAND)

Director of Health Services (Maggie Copeland) noted in her Briefing Note that the annual allocation of the Indigenous Health Equity Fund (IHEF) for Mississaugas of the Credit has been approved. Pursuant to the Chiefs of Ontario resolution passed at the Annual Chiefs Assembly in June 2024, the approved allocation will follow the Ontario First Nations Limited Partnership (OFNLP) formula for this fiscal year; an allocation of \$222,114.00 for fiscal year 2024/2025.

Through the approved allocation method, Ontario Region has prepared an amendment to MCFN's existing funding agreement to include the allocation of \$222,114.00 for fiscal year 2024/2025. Requesting and seeking approval to direct the IHEF of \$222,114.00 to the existing health plan to enhance the Primary Health Care program to hire 1 full time Nurse Practitioner, .5 Chronic Disease Nurse and 1 full time Execute Administrative Assistant.

Senior Director of Intergovernmental Affairs (who is covering for the Chief Administration Officer) informed that the Salary Grid will need to be upgraded.
