**AGENDA ITEM NO. 5 – REQUEST FOR A LETTER OF SUPPORT FOR A FUNDING  
APPLICATION – HEALING FOREST (EF)**

Councillor EF noted in her Briefing Note that Joanna Sparrow Archibald and Jackie Findley are volunteers who take care of the Healing Forest for Truth and Reconciliation in Burlington. They are requesting two letters of support. One for submitting their application to the National Centre for Truth and Reconciliation Grant to commemorate residential school survivors; and the other letter is for a Ceremonial Fire Pit to be placed in the Forest to assist in relationship building with the MCFN Members. This letter will be sent to the Mayor in Burlington.

MCFN Member Andrea King stated that these people came to Chief and Council in 2020, and were applying for dollars from the David Suzuki Foundation.

The community around the area of the Healing Forest do not like it as they do not want to see any trees cut down.

MCFN Member Andrea King informed that she has been a Knowledge Keeper since 2020.

With regard to the Indigenous Advisory Circle, Councillor LS stated that there are too many “Pretendians”, and he would like to know who is applying for the grant. Is it our Grant Writer – Zishan Mchaudry?

Andrea King stated that if MCFN applies for the dollars, that we need to keep the dollars in the Community as the CHRT dollars is sun setting soon.

Ogimaa-Kwe noted that there is a political element to this.

Chief Administration Officer will reach out to the Grant Writer to see if he has applied for these dollars.

Councillor JH informed that by the end of this year, this item will be brought back to the Council Table with more information. He also informed that the new Director of Economic Development is already working on this. The job posting for her (DSED) Assistant will go out in January 2025.

Ogimaa-Kwe noted that the DOCA Department needs the space.
