AGENDA ITEM NO. 9 – WORLD CUP 26 TORONTO HOSPITALITY PACKAGES FOR FIFA (CS)

Ogimaa-Kwe noted that Gavin Roth will be joining us this morning. There is disappointment for MCFN that the Host City Supporter did not work out. Gavin will explain this further.

Councillor JH and AS both agreed that we should have pushed for a little more recognition. Councillor JH added that we are the Host City and should not be just window dressing.

Ogimaa-Kwe informed that there are three Nations in BC who are fighting for the same thing – more recognition.

This item is on hold until Gavin joins us via Teams.

Council moved back to Agenda Item No. 6.

AGENDA ITEM NO. 6 – EVENT PLANNER – CONTRACT PERSON TO WORK WITH FIFA (THIS ITEM IS BEING BROUGHT BACK FROM LAST WEEK'S COUNCIL MEETING BY COUNCILLORS FS AND AS FOR 2ND READING)

Councillors AS and FS were to bring back a Briefing Note and recommendation outlining why they are opposed to the Motion from last week's Council Meeting which is listed below:

2nd Reading was not allowed as Councillors AS and FS are opposed.

Both Councillors AS and FS were opposed to last week's Motion as they wanted to see some MCFN Members apply for the position.

Councillor AS stated that there is a total of seven MCFN Members who are interested in the Events Planner position.

At last week's Council Meeting (Thursday, November 27, 2025) Councillor Leslie Maracle was the Chair and was unable to vote. At this week's Council Meeting she voted in opposition to Motion No. 3 above. The Motion is dead.

A new Motion has been put on the floor:

That the MCFN Regular Council directs the Chief Administrative Officer (CAO) to post the position of FIFA 2026 Events Planner.

Carried

2nd Reading Waived

There was no opposition to Motion No. 4.

Councillor EF noted that the Chief Administrative Officer has the authority to bring someone in on a contract basis for six months.

Councillor JH reminded everyone that it is not Chief and Council's role to tell the staff what to do.

Council moved back to Agenda Item No. 9.

Gavin Roth joined the meeting via Teams at 10:10 am.

AGENDA ITEM NO. 9 – WORLD CUP 26 TORONTO HOSPITALITY PACKAGES FOR FIFA (CS)

Gavin Roth stated that he represents the Host Committee for Toronto and has no control over MCFN wanting to be the Host Nation.

Councillor JH stated that at first he thought we were asked to join the meeting because we were the Treaty Holders. He also stated that it was very upsetting to him that MCFN is not on par with Toronto in recognition.

Ogimaa-Kwe informed that we agreed to be called First Peoples' Host.

Gavin questioned if MCFN is interested in buying any hospitality suites as they are selling out. Councillor JH answered that it is ironic that we are the Host Nation and we have to purchase hospitality suites.

Council did not decide if they were purchasing any hospitality suites or anything else.

Gavin was thanked for his presentation and left at 10:40 am.

AGENDA ITEM NO. 10a) – MOTIONS/DIRECTIONS (EF)

Chair/Councillor EF questioned the CAO as to what has become of the Motions and Directions since Council and other relevant parties do not receive them anymore.

CAO answered that he is putting a spreadsheet together listing the Motions that require action and will send the spreadsheet to everyone.

AGENDA ITEM NO. 10b) – CLOSING OF THE BUILDING DURING SNOW DAYS (EF)

Chair/Councillor EF questioned who would be closing the buildings when there are snow days. Whoever is in the building would lock the door and then the alarm automatically comes on. CAO stated that he will be giving authority to the Directors regarding whether or not they want to close their offices during inclement weather. However, closure would have to coincide with the school.

AGENDA ITEM NO. 10c) – SIGN-IN SHEETS (EF)

Chair/Councillor EF does not agree with the CAO getting rid of the sign-in sheets. The Health and Safety Committee stated that these sign-in sheets are necessary. CAO answered that some Directors were using it to track the attendance of their staff when they should be trusting their staff.

Councillor AS questioned what happened to the Health and Safety Committee. Chair added that the Health and Safety Committee needs to be updated. Ogimaa-Kwe stated that the Emergency Plan also needs to be updated.

AGENDA ITEM NO. 10d) – CANADA'S CARAVAN FOLLOW-UP (VKJ)

Senior Director of Operations noted that a presentation was provided by FIFA of their commitment set up of the FIFA 2026 Caravan on the First Nation. MCFN will be responsible for bringing in their speakers, artisans for signing and entertainment throughout the festival. This would be similar to what MCFN did for the torch relay with MCFN and Toronto PanAm Games.

Senior Director of Operations stated that if we pay \$50,000.00, FIFA will do everything in setting up the Caravan here at the First Nation. Chief Financial Officer informed that the CWJI dollars can be used.

It is noted that the Senior Director of Operations will be the contact person.

MOTION NO. 5

That the MCFN Regular Council agrees to notify FIFA Caravan in Toronto that MCFN would like the Caravan to come to the First Nation. The Caravan is part of the FIFA World Cup 2026 Event.

Cost is \$50,000.00 and the dollars will come from the CWJI (Community Well-Being and Jurisdictional Initiative) Funding Account.

The deadline to submit interest in participating in the Caravan is Tuesday, January 6, 2026.
