**AGENDA ITEM NO. 7a) – NOTICE FROM GRAND RIVER CONSERVATION AUTHORITY  
(GRCA) (AS)**

Chair/Councillor AS noted that there was a letter and season passes from Grand River Conservation Authority (GRCA). GRCA has sent season passes to Chief and Council and there is a notice in the letter that MCFN Members can also access GRCA for season passes to utilize the provincial parks in the GRCA area without having to pay unless it is outside the policy.

Chair requested permission that she be allowed to post this information on the Website and Newsletter so Members will be aware should they want to plan a picnic or outdoor event.

Councillor LS questioned how one would go about obtaining a season's pass. Would individuals have to provide identification as self-identity is an issue as well as Indigenous fraud. And what about protecting our hunter's identification as they will need to be protected.

**DIRECTION NO. 3**

That the MCFN Regular Council directs the A/Chief Administrative Officer (CAO) to post a Notice to MCFN Members regarding obtaining season's passes to any of the provincial parks in the Grand River Conservation Authority (GRCA) area.
