OFNEDA CLASS TOUR OF MCFN-(DS)**

Director of EcDev. Dale Sault brought this item to the table. Dale Sault was asking for permission for her class of Economic Development Studies to come and take a tour of Mississaugas of the Credit First Nation. She has been taking this course through Economic Development Studies from Ontario First Nation Economical Developers Association (OFNEDA)
